• The present procedure for the calculation of mid-month and monthend payroll deposits shall remain. Due to the involvement of contractual items with this procedure it could become a negotiable item at the end of this OSSTF contract period.

ronto January 20-22/83. Trustees L. Winslow and T. Delaney were also in attendance for this conference.


