

# Lake Superior Board of Education meets

The regular meeting of The Lake Superior Board of Education was held on Monday, April 18, 1983 at 7:00 p.m. in the Conference Room located at Marathon High School, the Board agreed to meet again on Tuesday, April 19th to

complete the agenda.

G. Conrad, Teacher Diagnostician, gave a presentation to the Board regarding the Special Education Review Process, Follow-up and Results of the Review.

The proposed Lake Superior Board of Education Parent Guide to Special Education was adopted as presented and is to be commercially printed for use within the Board. The Policy and Procedures Manual for Special Education was adopted as presented for use in the Lake Superior Board of Education, effective September 1/83.

Trustees M. Reid, D. Burton, G. Bodak and J. Nugent absented themselves from the Committee of the Whole Board for the Salary Committee report.

Minutes of Special Board Meeting No. 1/83 held March 14/83 were declared adopted. Minutes of Meeting No. 3/83 held March 21/83 were declared adopted. Minutes of the French Language Advisory Committee Meeting held March 1/83 and Minutes of the Special Education Advisory Committee Meeting held March 15/83 were acknowledged as received. Minutes of Special Board Meeting No. 2/83 held April 7/83 were declared adopted.

Disbursements for the month of March/83 in the total amount of \$620,221.19 and Payroll "B" disbursements for the month of March/83 in the total amount of \$20,562.62 were approved.

A special meeting is tentatively scheduled for Saturday, June 18/83 to establish Board Priorities and Directions.

The Board was reminded that responses

to the Allan Report are to be forwarded to the Minister of Education by June 30/83. The Management Committee is to meet and give direction to the Administration for the preparation of the Board's response.

Letters received from the Terrace Bay Recreation Committee and W. Morrill of Schreiber Public School were referred to the Property and Maintenance Committee.

The Board passed a resolution that they approach the Ministry of Education requesting capital funding for the roof of Schreiber Public School.

The Board was notified that Principals had been asked to attend the next committee meeting scheduled for Thursday evening, April 28, 1983.

The resignation of G. McDonald, Attendance Social Counsellor for Manitouwadge, was accepted with regret effective April 29, 1983.

The Board acknowledged the letter received from S. Mikus, teacher for Terrace Bay Public School, accepting her retirement from the Board effective August 31, 1983.

The Board approved an extension to the Maternity Leave granted to T. McDermott, teacher for Manitouwadge Public and High Schools, to include the school year 1983-84 (Sept. 1/83 -

Aug. 31/84).

The Board acknowledged receipt of the letter from A. Proudfoot indicating her intent to return to her teaching duties effective September 1/83 following her Maternity Leave from Manitouwadge High School.

The following Leaves of Absence (without pay) were approved by the Board:

- S. Quinton, 2/3 time teacher for Schreiber Public School, for the mornings of April 12 and 13, 1983
- F. Fry, teacher for Marathon Public School, for the mornings of April 21 and 22/83
- A. Sikorski, part-time custodian for Marathon High School for the period May 30/83 to June 18/83 inclusive,
- E. Saranpaa, teacher for Lake Superior High School, for the afternoon of Friday, April 25/83.

The Board approved the appointment of S. Hurley as Physical Education OUC for Lake Superior High School, effective April 5/83 to June 30/83, salary to be prorated according to schedule.

The Board approved the re-assignment of G. Conrad to the teaching staff of Terrace Bay Public School effective 1983 09 01 at salary according to schedule, upon completion of the term appointment as Teacher Diagnostician August 31, 1983.

The Board indicated that they would like to publicly acknowledge the many contributions to the System of Miss Gail Conrad. Trustee J. Nugent suggested that the loss to the System will be Terrace Bay's gain.

The Board approved the appointment of Kathy Cuma as Attendance Social Counsellor for Manitouwadge Public and High Schools effective May 1/83 at salary according to schedule.

The Board resolved that \$60,800.00 be transferred to the Reserve for Working Funds and \$5,000.00 be placed in reserve for Retirement Gratuities at the Secondary Panel for 1982; that \$10,000.00 be transferred to the Reserve for Working Funds and \$5,000.00 be placed in

reserve for Retirement Gratuities at the Elementary Panel for 1982.

Mr. N. Critchley, the Board's architect, reviewed with the trustees his analysis of the school facilities, especially in Manitouwadge Public School and Marathon Public School, and the proposed solutions re same. The Board was informed that Mr. Critchley and the Director of Education were meeting with Ministry officials in Thunder Bay on Wednesday, April 29th/83 to discuss the projects for Manitouwadge and Marathon.

The next regular meeting of the Lake Superior Board of Education will be held on Monday, May 16th, 1983 at 7:00 p.m. in the Manitouwadge Public School gymnasium.

The Ontario Ministry of Natural Resources has good news for campers planning to spend a quiet holiday in a provincial park enjoying the

peaceful outdoors. The ministry is increasing its efforts to ensure that no one's vacation is disturbed by the actions of a few inconsiderate campers.

"Our provincial parks are widely praised for their security and peacefulness," Natural Resources Minister Alan Pope said today. "We want to maintain a noise level acceptable to all campers - especially when music and parties are involved."

He said many park users have asked that more be done to control noise levels, "and we have a responsibility to them which we intend to fulfill." Action against excessive noise-makers will begin as soon as the first provincial parks open on Friday, May 13.

"These actions are reasonable, aimed at giving everyone a chance to enjoy a peaceful visit to a provincial park. I know they will be embraced by an overwhelming majority who want to spend an enjoyable vacation with family or friends," Mr. Pope said.
