Constitutional case in Schreiber

of, or assault on police, come before the courts in Schreiber, there was nothing unusual in the procedures being followed until the Crown closed its case after having presented its evidence.

Judge Rod Clarke interrupted the trial at this point and said that he was about to do something that might be viewed as inappropriate but which he felt was necessary. Judge Clarke asked the Crown and the Defence to briefly review the evidence with him for a moment and specifically asked whether or not the Crown

had introduced any evidence showing that the defendant had been informed of his new Constitutional rights under section 10 of the Charter of Rights and Freedoms. These include, "The right upon arrest to be informed promptly of the reasons; to be tried within a reasonable time; to be presumed innocent until proven guilty; not to be denied bail without just cause; and the right to the assistance of an interpreter."

The Crown conceded in fact no evidence had been introduced to show that the defendant had been informed of his rights. The Crown then offered to recall the constable to the witness stand to clarify the point. However, the Crown had already presented its evidence and closed its case, and Judge Clarke ruled that that would not be appropriate.

It was becoming increasingly obvious that the Judge was seriously concerned about the Constitutional points, and might well decide the case on that basis alone without considering the merits of the evidence that had been presented.


