 A letter was received by Council from Marathon Realty regarding an option to purchase and purchase agreement for the parcel of land behind the Senior citizens Apartments for the sum of \$33,000. The Reeve and Clerk were given permission to sign an agreement of purchase with the firm, whereby a parcel of land adjacent to the Senior Citizens Complex be acquired for the mentioned sum of money.

Police
 By-Law #776 was passed, being a by-law to prohibit bicycles on sidewalks within the township of Schreiber.

Labour Relations
 Negotiations have been completed with CUPE, Local 87 for a one year agreement covering all unionized employees as well as the non-unionized personnel. A resolution was passed that Council ratify the agreement negotiated with Local 87 of CUPE whereby a new agreement was reached granting a rate increase of 8 per cent and minor changes to the benefit package, the changes do not include monetary items in the benefit package.

In another resolution, the Clerk-Treasurer, the Assistant Clerk-Treasurer and the Township Engineer were granted an increase of 8 per cent for the period of May 15/84 to May 16/85.

General Accounts to the amount of \$44,804.73 and Water Works Accounts to the amount of \$16,663.05 were approved and paid.

Council approved a contribution to the McCausland Hospital in the amount of \$650 towards the cost of their presentation at the various recruitment seminars sponsored by the Under-served area programme.

Report on R-271 Subdivision
 Tree clearing is required in the area of R-271 which is to be used as a drainage easement and to allow for the placement of fill on lots close to the drainage easement area. K. Dooley be hired to cut and clear the bush from the drainage easement

through the R-270 and R-271 area for the sum of \$5,500. It is understood that all salvagable timber can be removed by K. Dooley.

Notice has been received from the Ministry of Housing that all provincial ministries are satisfied that the draft plan of subdivision for the R-271 area meets their requirements. Approval will be given to the Township to proceed with the registration of the plan after final comments are evaluated by the Ministry of Municipal and Housing.

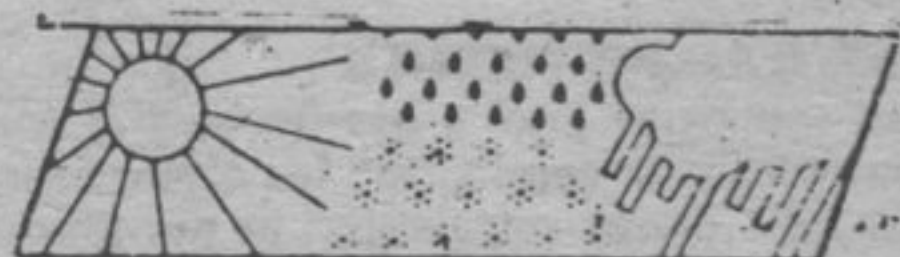
