Policy:

All persons who join any of the following organizations must have at least one type of membership with the Terrace Bay Recreation Association: curling, minor hockey, adult hockey, figure skating, bowling league, broomball, ringette, boxing, swim lessons, minor baseball or any other club or organization which falls directly under the sponsorship of the Terrace Bay Recreation Association.

Full Memberships:

Full memberships are for families or single Recreation persons. memberships must be on a continuing basis and dues must be paid by the deadline of January 1st each year. All immediate family members are included on a full membership, i.e. nonworking children under the age of 25 and living at home, dependent students either local or away who are under the age of 25.

Privileges of Full Memberships:

Reduced rates for squash and racquetball courts, open bowling, roller skating, or any recreational where a non-member and member fee is charged. You are able to book squash and racquetball courts one day in advance. Free public skating and swimming. Reduced rates for tournaments sponsored

by the Recreation Department. Free use of the fitness room and saunas.

Non Resident (short term) Membership:

Only available for those temporily employed in Terrace Bay. Expires 6 months after date of purchase. Covers only one person. This membership cannot be renewed. If the holder is still living in Terrace Bay after the membership has expired, and still wishes to be a recreation member, he/she must purchase a full membership. Privileges for a non-resident are the same as for a full member.

One Activity Member-

This is designed for persons who wish to participate in one-activity only and must be recreation members in order to participate. Listed below are the one-activity memberships available. Curling, Minor Hockey, Adult Hockey, Figure Bowling Skating, Leagues, Swim lessons, Tennis Club, Broomball. This membership expires at the conclusion of activity season. No membership card is issued. Covers only one person. Privileges of one activity membership -Enables person to participate in one-activity

# ASSESSMENT

## and your 1985 Municipal and School Taxes

Regional Offices located throughout Ontario are responsible for assessing all real property for the purposes of municipal and school taxation.

The resulting Assessment Rolls are delivered to municipalities which use them

to set their mill rates and compute municipal property tax bills.

The amount of property tax you pay on your home or business depends on the assessed value and the mill rate set by your municipality. The assessed value multiplied by the mill rate will determine your 1985 property taxes.

**Open House Sessions** 

Open Houses are your opportunity to fully understand your assessment and to evaluate its equity.

Open Houses are held in every municipality at convenient times and locations, to provide you with the opportunity to discuss your assessment with staff of the Regional Assessment Office.

An assessor will be pleased to explain the basis of your property assessment and is authorized to amend any information as may be necessary prior to the delivery of the Assessment Roll to your municipality.

If you have any questions but are unable to attend the Open House, please contact your Regional Assessment Office at the address or telephone number shown below.

**Assessment Notice** 

Property owners and tenants will receive an Assessment Notice only if information regarding their property or assessment was changed during the past year, if the assessment was appealed last year, or if the property has been reassessed under section 63 of the Assessment Act. If you receive an Assessment Notice, it may reflect changes you have requested in your school support designation, in the amount of your assessed value, or other recorded information on last year's Notice.

Appeal Procedure

If, after attending your local Open House, you are still dissatisfied with your assessment, you have a right to appeal it to the Assessment Review Board. The Assessment Review Board conducts informal hearings and is responsible for determining whether the assessment under appeal is fair and equitable with the assessments of similar properties in the vicinity or neighbourhood, and may alter your assessment accordingly.

Appeal Deadline

The final date for appealing your assessment

is January 9, 1985.

Your appeal must be forwarded, either on a Notice of Appeal Form or as a letter, to the Regional Registrar of the Assessment Review Board on or before January 9, 1985, noting your property address, Roll Number and the reason for the appeal.

To assist you in this regard, Notice of Appeal forms and the address of the Regional Registrar of the Assessment Review Board are available at Open Houses, your Regional Assessment Office, or your municipal office.

continued from page 2 behind the hotel was a steep hill side. A little waterfall came toppling down it amid maples, cedars and aspens, spruce.

During breakfast of apple juice, sausages and eggs, I asked questions of the waitress. She said the building has been in her family for many years, from her great grandfathers time. The owner now is Ned Basher from New York. Trains only stop at Rossport now on special order since the 1970's.

Lorraine gave me the name of Mrs. Anne Todesco and stated that she knew a great deal of the history of the village. I wrote Mrs. Todesco and even though I sent her a U.S.A. stamped envelope she was kind enough to replace it with a Canadian one. She wrote me some history of the Village of Rossport.

The population of the village averages 150 to 200 according to the season. Formerly the livelihood was solely a commercial fish industry, plus fur trapping. The fishing is down to only one steam tug now owing to the lamprey eel invasion and more tourists fishing and taking home tons of fish. There used to be about twenty fishing vessels operating out of the village (W.D. and I didn't fish any but when we walked down to the dock, we could see a school of fish swimming in the deep water)

"Local people work on the highway now since it started construction in the 1930's" she continued "Before then, the only entrance to the village was by train or boat. Some villagers work at the Terrace Bay pulp mill or on the railroad".

The school was closed in the sixties and the children bussed to Schreiber. There are two churches, the Roman Catholic and the Union church used by all protestant religions. Both were built in the 1880's. In winter when the temperature is down to 50 degrees below zero or above, the islands in the bay continue to stand like sentinels, guarding the harbour and village. They remind me of Psalm 121 "I will lift up mine eyes unto the hills - The Lord shall pre-
