


Steve Webber: "I plan on getting to most of the sports events."

A visit with industrial relations

Since I have taken on the job of Editor for the Terrace Bay Schreiber News only recently, I have had many ideas and notions of what my job will actually involve. As we will be providing our readers with pertinent local news, thought the first thing I should do was familiarize myself with the businesses and people that contribute to the growth, financially, emotionally and spiritually to Terrace Bay and Schreiber. Well you guessed it, what better place to start than with Kimberly-Clark?

We are all familiar with the history of this Mill in our town, we know that Kimberly-Clark provides most area residents with employment, we know that Kimberly-Clark began the development of Terrace Bay, they provided Recreation, and leisure facilities for the employees. They ran the Hospital, the Hotels and pretty well everything else. Well, if I may say so they have done a very good job in providing a clean, comfortable, secure place for young and old alike.

It is not my job to run down the last 39 years of the Mill in Terrace Bay, or do an extensive profile of the operation (I'd be here for weeks), so I thought a visit to Mr. A.N. Chisholm, Director of Industrial Relations for both the Mill and Woodlands would give me a general rundown.

Mr. Chisholm has been with Kimberly-Clark for 25 years. He was in Terrace Bay in the early days and returned in 1982 to concentrate on Employee Relations, and Incentive. Mr. Chisholm's job is very involved, he is active in labour negotiations, payroll and company policies. He manages job descriptions and evaluations, takes care of all Public Relations, and property owned by Kimberly-Clark of Terrace

His most important duty of all, I think, is job safety. We discussed safety for some time and Mr. Chisholm assures us he takes a very active role in the Pulp and Papermakers Safety Association, both Canadian and Northwestern Ontario. He at-

tends all conferences this organization holds and does his best to keep abreast on all new ideas, and procedures to maximize safety in the work place. The Kimberly-Clark mill here is one of the safest operating mills in the country, and the logging operation is only second to one in Ontario. Safety is a constant concern and Mr. Chisholm, with his staff of 21, work hard in reminding the employee that safety starts with them, and everyone must work together to ensure personal safety to all.

I asked Mr. Chisholm about the infestion of the budworm in our area, and though we did not have the time to debate the pros and cons, he admits there is a problem that must be closely monitored, and cannot be allowed to continue.

Mr. Chisholm made reference to Nova Scotia and New Brunswick, who lost at least 53 per cent of their growing stock of fir and white spruce to the budworm.

We also talked briefly of the move Kimberly Clark

has made to make land available to the town for purchase. As Mr. Chisholm agrees, Kimberly-Clark has worked hard to maintain standards in this community, and we have reached a

point where more influence and divergence, applied with the same strong standards would be beneficial in tapping all of this community's potential. When asked if Kimberly-Clark had any plans of land

development in the near future, Mr. Chisholm told us to be listening for an announcement coming soon in that regard.

Well, that's about all I have to report on my first visit in many years to the Mill. I look forward to close communication with Mr. Chisholm and will let you know any information that I receive. I also look forward to engaging in more informative profiles in the future.

Police Report Police help hospital
