THE MUNICIPAL ELECTIONS ACT **SECTIONS 24 AND 25** 

NOTICE is hereby given that I have complied with Sections 24 and 25 of the Municipal Elections Act and that I have posted up in my office at Terrace Bay, Ontario, on the 9th day of October, 1985, the list of persons eligible to vote in the municipality at municipal elections and the list remains there for inspection.

And I hereby call upon all such electors to examine the list and to take immediate proceedings to have any errors or omissions corrected according to law.

The last day for filing applications for inclusions, additions, or corrections to or deletions from the list is Wednesday, the 23rd day of October, 1985.

The place at which the revisions of the list will be taken is the Township of Terrace Bay Municipal Office, 12 Simcoe Plaza, Terrace Bay, Ontario.

Revisions of the list will be undertaken during normal office hours, 8:00 a.m. to 4:30 p.m., Wednesday, October 9, 1985 to Wednesday, October 23rd, 1985.

#### QUALIFICATION OF ELECTORS

A person is entitled to be an elector in a municipality if he is not disqualified under this or any other Act or otherwise prohibited by law from voting in the election and if, at any time during the period commencing on the Tuesday following the first Monday in September in an election year and ending on the Wednesday in October that preceds polling day by nineteen days, he,

(a) is a resident in such municipality or is the owner or tenant of land in the municipality or the spouse of such an owner or tenant;

(b) is a Canadian citizen or other British subject; and

(c) has attained the age of eighteen years or on or before polling

Notice is hereby given to the Municipal Electors of the Township of Terrace Bay in the District of Thunder Bay that the period during which nomination papers may be filed in the office of the Clerk for the purpose of municipal elections will commence on Thursday, October 17, 1985, at 8:00 a.m. and continue during the normal office hours of the Clerk until the close of nominations on Monday, October 21, 1985, at the hour of 5:00 o'clock in the afternoon.

Nominations will be received for the office of:

- (a) Reeve
- (b) Councillors (4 to be elected)
- (c) Trustee representing Separate School electors on the Lake Superior Board of Education (1 to be elected)
- (d) Public School Trustee for the Lake Superior Board of Education (3 to be elected)
- (e) Separate School Trustee for the North of Superior Roman Catholic Separate School Board (2 to be elected)
- If there was an insufficient number of candidates for any office, additional nominations for the remaining vacanies in any office may be filed in the office of the Clerk on the Wednesday following nomination day between the hours of 9:00 o'clock in the forenoon and 5:00 o'clock in the afternoon

## QUALIFICATIONS OF CANDIDATES

- (1) A person may be nominated as a candidate for an office by filing, either personally or through his agent, in the office of the Clerk, on the days and during the hours specified in subsection 2 of section 35, a nomination paper in prescribed form which,
- (a) shall be signed by at least ten electors whose names are entered in the preliminary list of electors or who have made application to have their names included on the list and who are entitled to vote in the election of such office:
- (b) shall state the name and address of the person nominated in such manner as will identify him and the office for which he is nominated; and
- (c) shall state the name and address of each elector signing the nomination paper and, where the office for which the person is nominated is a member of a school obard, that such nominator is a public school elector or a separate school elector, as the fact is.
- (1a) The address referred to in clauses (1) (b) and (c) shall be the address within the municipality of the person nominated or the elector signing the nomination paper, as the case may be.
- (2) No nomination is valid unless there is filed with the nomination paper a consent in writing to the nomination and a declaration of qualification in the prescribed form by the person nominated.
- (3) A nomination paper nominating a person for an office the holder of which is required to be elected by public school electors shall be signed by public school electors.
- (4) A nomination paper nominating a person for an office the holder of which is required to be elected by separate school electors shall be signed by separate school electors only.
- (5) Each person to be nominated for election to an office shall be nominated by a separate nomination paper, but an elector may sign more than one nomination paper for the same person and the nomination papers of more than one person.
- (6) After a nomination paper is certified by the Clerk it shall remain in the possession of the Clerk but shall be open to inspection by any person during the normal office hours of the Clerk.
- (7) The onus is on the person nominated for election to an office to file a bona fide nomination paper.
- (8) For the purposes of this section, the determination as to whether an elector is a public school elector or a separate school elector shall be in accordance with the support indicated on the list of electors delivered to the Clerk under section 22, as revised up to the time the nomination paper is filed.

If a greater number of candidates than required to fill the above offices are nominated, an advance poll will be held on Saturday, November 2, 1985, at the Terrace Bay Municipal Offices (9:00 a.m. to 8:00 p.m.) and the regular poll will be held on Tuesday, November 12, 1985 (11:00 a.m. to 8:00 p.m.).
