

Schreiber Reeve and Councillors sworn in

"Our top priority is the completion of the Fire Hall," the new Reeve of the Township of Schreiber, Mike Cosgrove, said in his inaugural address to council on Dec. 10.

He added that the council will also have to provide more residential lots as required while, at the same time, remaining "extremely budget conscious."

He said a new committee system will be instituted, whereby all the members of council will serve on two different committees.

Reeve Cosgrove told the

new council members that they were all elected to serve the people, and with their co-operation he hoped to do this to the best of his ability. The election was held on Nov. 12.

The inaugural meeting began with the Declaration of Office and the Oath of Allegiance by Reeve Cosgrove and the four new township councillors: Ed Borutski, Gerry Godin, Bob Krause and Tom Quinton. All four councillors also made inaugural speeches following the swearing in ceremonies.

Councillor Borutski pro-

mised to co-operate fully in all aspects of council work. He agreed with the Reeve that the completion of the Fire Hall was a top priority, but he also mentioned the development of the R-271 subdivision.

"I would like to see more sidewalks installed north of Drummond Street," he concluded.

Councillor Krause, in his speech, said he hoped that additional land for a cemetery would be acquired by the township. He also felt that the township should consider hosting the Northern Ontario Municipal Association (NOMA) convention during the current term.

The existing community spirit was mentioned by Councillor Godin, who added that he hopes this spirit continues and grows. He felt the expansion of the present sewer system should be given priority, and also mentioned a study of the future needs of the community should be considered.

Council will be required to provide input for the Official Plan, Councillor Quinton noted. He said one thing council should think about is obtaining a better

balance of the education tax levy.

Quinton also discussed the viability of maintaining the old Town Hall as well as the possibility of more

effective road maintenance programs, especially at Walker Lake, which is just west of the town.

Later in the meeting council was told that snow

machines are again becoming a problem in the area.

The township's Christmas Party was also held last week, a few days after the council meeting.

BY-LAW NO. 803

Being a by-law to amend By-law 631 of the Corporation of the Township of Schreiber

WHEREAS: The Council of the Township of Schreiber deems it advisable to amend By-law 631, in respect of the permitted uses of Lot 11, Section 4, Plan 826 & Pt Lot 10, Section 4, Plan 826.

AND WHEREAS: Pursuant to Section 39 of The Planning Act, Chapter 379, R.S.O., 1980 may do so.

NOW THEREFORE: The Council of the Corporation of the Township of Schreiber enacts as follows:

1. That By-law 631 be amended by adding the following paragraph to Schedule "GC", namely:

"Notwithstanding any zoning maps of By-Law 631, and Section 9.1, "Permitted Uses" of By-law 631, the permitted use of the following land and premises namely":
"All and singular", that certain parcel of land consisting of Lot 11 and part of Lot 10, Plan 826, Section 4, 303 Scotia St., in the Township of Schreiber will be "Multiple Dwelling" excepting that all of the basement area, and 30% of the first floor area, will be designated "General Commercial", and the permitted uses consistent with the General Commercial Zone, will apply to the area designated General Commercial.

Read a first time this 10th day of December, 1985.
Read a second time this 10th day of December, 1985.
Read a third time and finally passed this 10th day of December, 1985.
