In the meantime, some of the boys decided to prepare a rink on the harbour ice, but Old Man Winter decided otherwise.

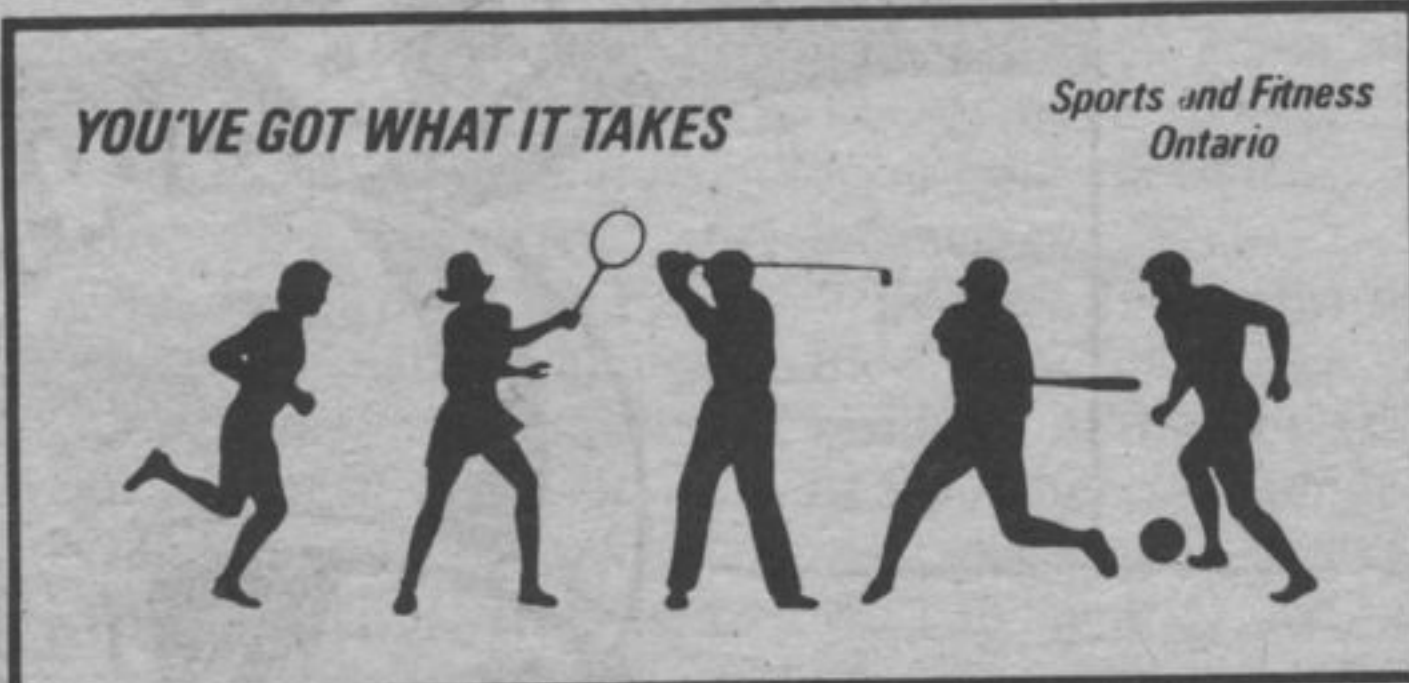
The strong winds opened up the ice field and destroyed the rink.

Close call

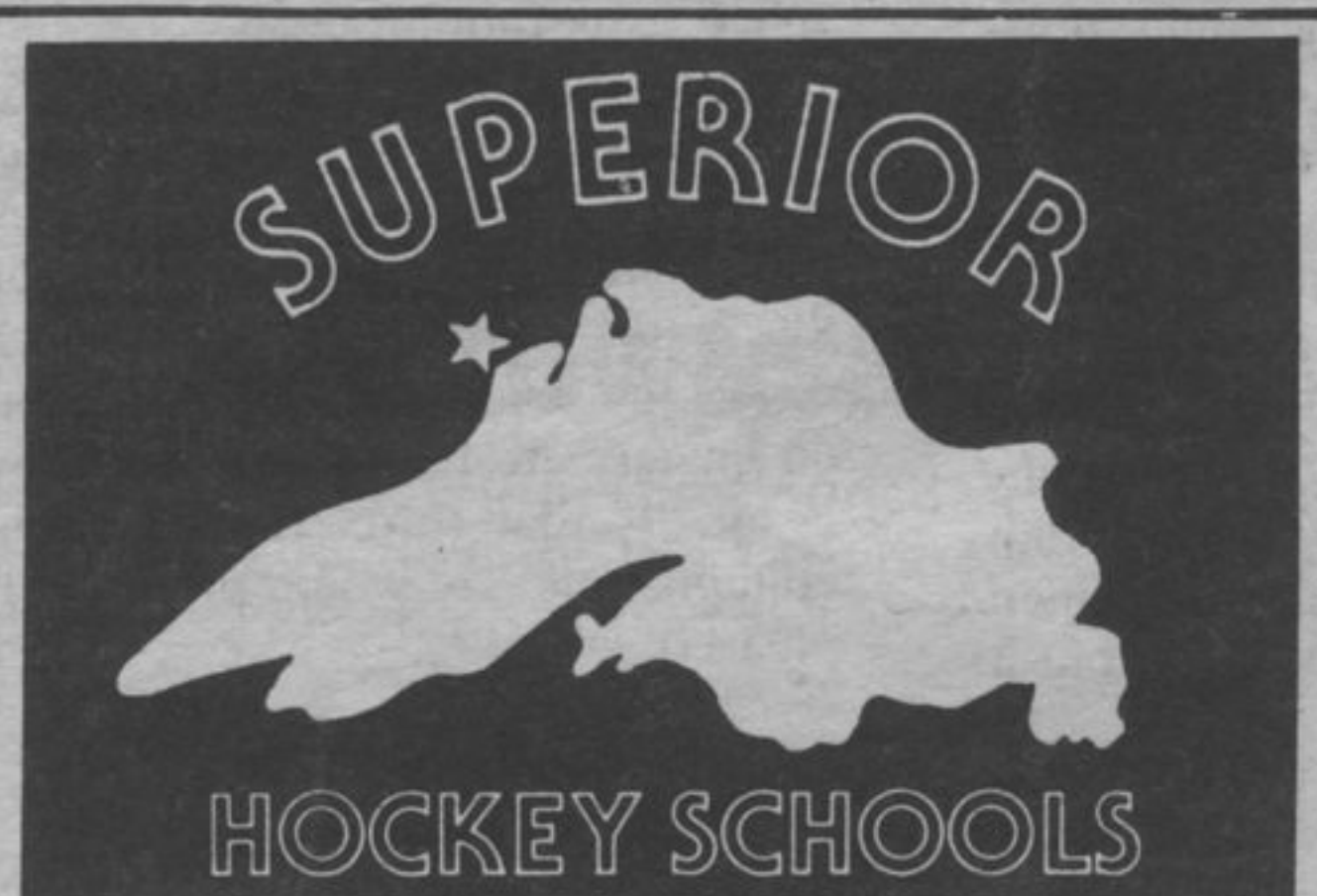
