

MP Penner peeved

Cochrane-Superior Member of Parliament Keith Penner has sent letters to the Secretary of State and the Minister of State for Youth earlier this month to complain about the "very disappointing" decision by the federal government to cease funding of the Katimavik program.

"This decision is very disappointing and discouraging to the youth of this country," Penner said in both letters. "While I understand the government's desire to reduce the

deficit, it should not be done at the expense of Canada's youth."

Penner told the Secretary of State, the Honourable Benoit Bouchard, that it is difficult to understand why a program which is so cost effective has been cancelled. The program has won national and international acclaim in its ten years of operation. Katimavik offers a chance for young people to mature, gain self-respect, and learn new skills.

In his letter to the

Honourable Andree Champagne, the Minister of State (Youth), Penner said, "I ask that you, spokesperson for Canada's youth, make strong representation to your Cabinet colleagues ... in order to reverse this detrimental decision."

He pointed out that the program has provided meaningful experience to the youth of the country, while offering essential services to municipalities and community organizations. Both letters were dated February 6.

More boxes at P.O. now open

The Canada Post Corporation has made available 60 new lobby lock boxes at the Post Office in Schreiber, according to a February 6 news release from the Mid-West Division of Canada Post. The additional Post Of-

fice boxes, which were made available for rental late last year, bring the total number of lock boxes at the Schreiber location up to 816.

Individuals, businesses, and community groups

wishing to secure a lock box should contact the Schreiber Postmaster. Boxes are available on a first come, first served basis.

In other Canada Post news, the corporation recently announced the addition of state-of-the-art counter scales at the Post offices in both Schreiber and Terrace Bay.

The scale is a Pitney Bowes 4605 electronic model, considered one of the most sophisticated weighing systems available.

According to Ed Sedleski, Mid-West Division Project Specialist for Retail Sales and Merchandising, the scales were first introduced in Atlantic Division and are now being in-

stalled across the country, with 17 in Northwestern Ontario.

"The accuracy of the new scale is second to none," he said. It is designed to weigh both parcel and letter mail from one gram up to 35 kilograms, with a remote digital readout that gives the customer a chance to see the exact weight of the item being offered for mailing.

Pitney Bowes is supplying about 3,500 scales to Canada Post at a cost of more than \$3 million, but Sedleski feels the money is well spent.

"The new scales will be major assets to counter service, productivity, and revenue generation," he explained.

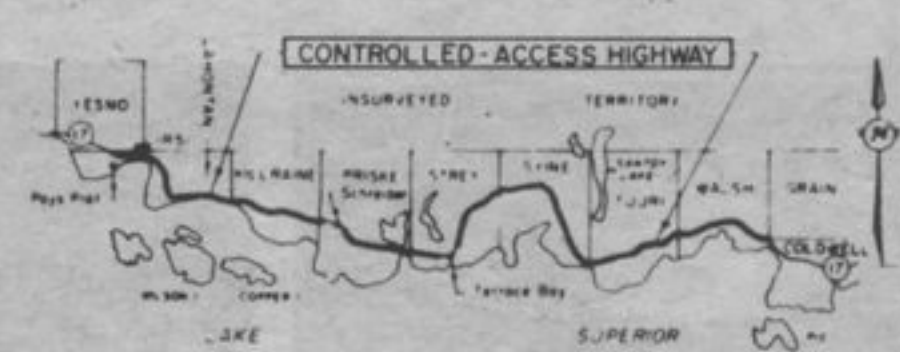
ONTARIO GOVERNMENT NOTICE

THE PUBLIC TRANSPORTATION AND HIGHWAY IMPROVEMENT ACT
PUBLIC NOTICE

IS HEREBY GIVEN that pursuant to Section 36 of the Public Transportation and Highway Improvement Act (R.S.O. 1980, c.421 and amendments thereto) the Lieutenant Governor in Council did designate the highway known as Highway 17 (Trans Canada), as a Controlled-Access Highway.
