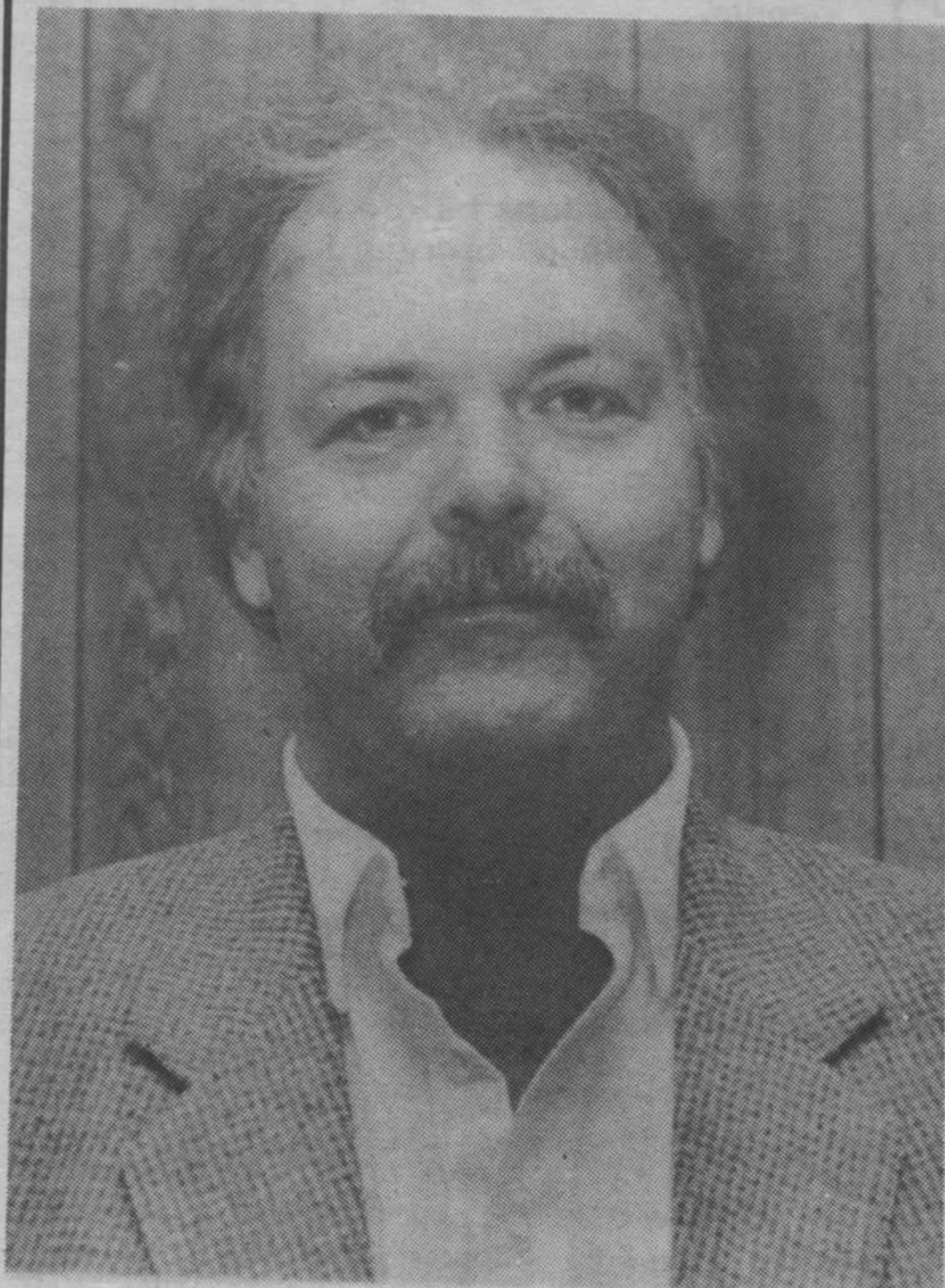

NOTICE OF THE PASSING OF A ZONING BY-LAW BY THE TOWNSHIP OF SCHREIBER

TAKE NOTICE that the Council of the Township of Schreiber passed By-Law 86-6 on the 14th day of April, 1986, under section 34 of The Planning Act, 1983.

AND TAKE NOTICE that any person or agency may appeal to the Ontario Municipal Board in respect of the By-Law by filing with the Clerk of the Township of Schreiber, P.O. Box 40, Schreiber, Ont. P0T 2S0, not later than the 19th day of May, 1986, a notice of appeal setting out the objection to the By-Law and the reasons in support of the objection.

An explanation of the purpose and effect of the By-Law, describing the lands to which the By-Law applies, and a key map showing the location of the lands to which the By-Law applies (or, alternatively, an explanation as to why a key map is not provided) are attached. The complete By-Law is available for inspection in my office during regular office hours.

*NOTE: Current Regulations require that an objection must be FILED WITHIN 35 DAYS OF THE PASSING OF THE BY-LAW. The previous notice allowed 35 days from the Date of Notice. IF YOU WISH TO OBJECT NOTICE OF THE OBJECTION MUST BE FILED BEFORE MAY 19, 1986, REGARDLESS OF PREVIOUS NOTICE.
