

My Fries are really her fries

The reason the french fries at Tanice Marcella's My Fries restaurant in Terrace Bay still have their potato skins on is simple: when she first opened her shop late last month, Marcella didn't have her potato peeler hooked up yet.

Customers told her how much they enjoyed the unpeeled taste, and so she never did plug that potato peeler in.

She decided to open the shop after returning from Europe on May 17 follow-

ing a seven month visit to that continent.

At first the take-out restaurant was just going to sell homemade fries and hamburgers, but then she expanded the menu to include some other items, like big sandwiches and pizza pops.

Her biggest seller at the store, located in a building owned by her father at the Mill Road intersection off Highway 17, is something called the LC Bronco Burger, which is a quarter-pound hamburger with all

the trimmings.

The name comes from its inventor, Lorraine Desauliniers, who made the burger recipe and design.


The french fries come in three different sizes and are cut fresh every day, Marcella explained.

As for the name of the store, she said that sometime body had asked her who would be making the fries once the restaurant was open, and she replied they would be "my fries," and that sounded as good a

name as any.

Two full-time cooks have been hired for the shop as well as three part-time students. My Fries is open at 6:30 a.m. with a full line of breakfast food and closes at 11 p.m., or 12 midnight on weekends.

To place your order ahead of time, she urges customers to call 825-9625. The store will be opened on a seasonal basis only. What will Marcella do during her time off? Why, travel to Europe again, of course!

According to a Foundation news release, Francois Duchesne began his voyage on May 16 in Halifax, with his final stop to be at the Canadian Pavilion at Expo 86 in Vancouver, B.C.

The Miles For Wishes Bike-A-Thon will last approximately three months. Francois became involved in the organization a

number of years ago when he lost his five-year-old sister to Cystic Fibrosis. The release said this experience "created an empathy in the young man towards all the children who may find themselves in need of the foundation's

To date the foundation has granted 57 wishes to terminally ill children living in Consider

ing in Canada.

"(We) hope to provide the family with some special memories, not just final images of hospitals, doctors, and equipment," the release explained. "During a time of heart-wrenching turmoil for a family, a 'wish' provides a welcome respite—a time of normalcy and just plain fun."

The release included a number of examples of what has done in the past. Bradley, 15, of Ontario wanted to meet Mr. T of The A-Team, and early last year Bradley and his family flew to Los Angeles and spent some time with the celebrity. The family also visited Disneyland.

Also last year, 10-yearold Sara asked for a stuffed animal and to go to her favourite restaurant with her family. The Foundation gave her a three-foot-high stuffed pony while she was having dinner with her family at the restaurant of her choice.
