project near Schreiber recently sold to Kerr Addison Mines, told the group at the meeting that the company was always prepared to hire some local residents for the mine.

'Our original estimate was 25 per cent (of the 140-strong workforce), but that estimate may certainly be conservative now,' he

said, referring to the layoffs. He said the mine will do everything in its power to hire some of the laid-off K-C employees and, in Premier Peterson's words, 'turn some forestry guys into miners.'

Smrke did ask Peterson financial for some assistance in terms of retraining funds, and Peterson agreed to be helpful.

'What has to come out of this is something for the man and woman on the

street,' Reeye Chapman said. 'They feel betrayed a bit. It's almost a state of paranoia... the survival plan doesn't mean anything to them.'


'We put a lot of time and effort into the plan,'

Chisholm said. 'We're looking at things positively.'

Later, Reeve Chapman said that the meeting succeeded in 'giving us a little more confidence. We don't want to see that little

Messy Schreiber homes = fines

Schreiber Those residents who have been breaking the township's property standards by-law may be in for a fine of up to \$500 for each day the by-law is contravened, thanks to a by-law amendment passed by Schreiber Council at its September 9 meeting.

Council was asked to take action after a delegation of concerned citizens appeared at the meeting. Reeve Mike Cosgrove informed them that Council has been proceeding against those who have been ignoring the by-law.

He explained that 15 letters had been sent out on Sept. 3. Each letter was actually an order issued in conjunction with a notice of violation concerning the

by-law. The order allows 14 days for an appeal. Reeve Cosgrove admitted that as of the meeting, no appeals have been received and, in fact, one town resident had actually refused to accept the order, sent by registered mail.

The orders call for the person's yard to be cleared of rubbish and debris, and that heavy undergrowth such as grass be cut. All wrecked, dismantled, or abandoned vehicles must also be removed.

'Longlac is having the same problems as we are having here,' Councillor Bob Krause pointed out. 'They have to go through the courts... there are some people who will defy you, they want to go to court.' He added that Council will

not back off on the problem.

Later on at the meeting, Council passed its by-law amendment establishing a fine of no less than \$500 per day for each day the by-law is broken upon conviction.

'This gives us the option to go to court instead of just actually doing the clean-up work ourselves,' clerktreasurer Aurel Gauthier said. 'If we go to court, we need something for the judge to work with.'

Ironically, earlier in the meeting, the awards for the annual Schreiber Beautification Contest were presented to the winners.

Council also passed a by-law to adopt its Official Plan. Gauthier noted that there are still some


