## Bell telephone spending money locally Terrace Bay- Bell Canada's tax con-

tribution locally as a result of telecommunications operations in 1986 totalled \$53,400.

Last year Bell spent \$471,000 in this area to maintain and upgrade telephone service. The 1987 cost is expected to be \$78,000.

There were 1,006 customers in the Terrace Bay exchange at the end of 1986.

In 1986, Bell paid \$53,413.26 in taxes to Terrace Bay as follows: real estate, \$1,365.24; business, \$409.57; and gross receipts, \$51,638.45 or \$28.51 per phone. In 1987, gross receipts tax will total \$54,047.55.

The gross receipts tax is a levy of five per cent of all telecommunications revenue derived from Bell operations in Ontario the previous year and apportioned to each exchange based on the number of Bell-owned telephones in use in the exchange.

Company-wide, Bell's capital expenditures this year will likely total \$1.787 billion, with Ontario's share more than \$1 billion.

Our thanks to our ever-faithful card players who came in on the 26th for an afternoon of bridge and cribbage.


On Friday, the 29th, some of the residents drove into Schreiber to visit their friends at the Chimo Club. Those folks always make us feel so welcome.
