After these victims had been dressed to 'perfection', the guides and pathfinders, in groups, took turns going through the proper procedure depending on the type of affliction.

The girls, some from Schreiber as well, have been working on

their First Aid Badge and have for the last three weeks been taking a first aid course.

Monday night's exercise was the culmination of what they learned.

The Girl Guides only were working on their badge; the Pathfinders were there just to observe and learn.

During the last three weeks, the guides learned practical things like how to apply splints and bandages, as well as theory from Dave Allan.

Many relations and friends attended the funeral of Mrs. Inez McCuaig at the United Church.


Rev. Hunt spoke of Inez as a
