Local chapter

Dickson said that about one year ago the local committee was formed. It represents Schreiber, Terrace Bay, Rosport and Pays Plat.

The committee presented a proposal to the government and the go ahead was given to proceed with the initial phase.

In January of this year the initial phase began and Dickson has since then been finding out what problems exist here and what methods would best address them.

The committee has by the end of this June to ascertain what the problems are and how they should be approached.

At this time, the committee will make another proposal to the government for a five-year phase.

Proof must be given to the government in order for the phase to be initiated, said Dickson.

Five options

Once the problems are exposed, communities have five options to choose from to resolve them.

*The first is the self-employment incentive. It would basically

help the unemployed become employed; unemployed who are either on unemployment insurance or on welfare.

There is funding available for this and the person must stick with the program for one year.

*The second option is the business development centre.

An office could be opened in town and its three major objectives would be to increase business, maintain present business and to offer business loans.

*A third option is the training option. Businesses in town could purchase either training or people in that area to help their employees become more valuable.

*The fourth is the re-location assistance option. Persons who have been laid off or who are unemployed receive assistance to seek work elsewhere.

Assistance would pay for the costs of interviews and relocating, for example.

*The fifth is the community initiatives fund; the money in this option is controlled by the minister and not all that easy to access, said Dickson.

Money from this has in the past been used for things like marina projects, mini malls and hospital extensions.

Dickson has since January been determining what needs there are here and what options

would best suit the needs.

She has been surveying the communities and interviewing many people.

Economic development

Dickson echoed Moore's state-

ments when she said that in order to have an economic development committee established (EDC), there must be a lot of interest shown on the part of the town councils.

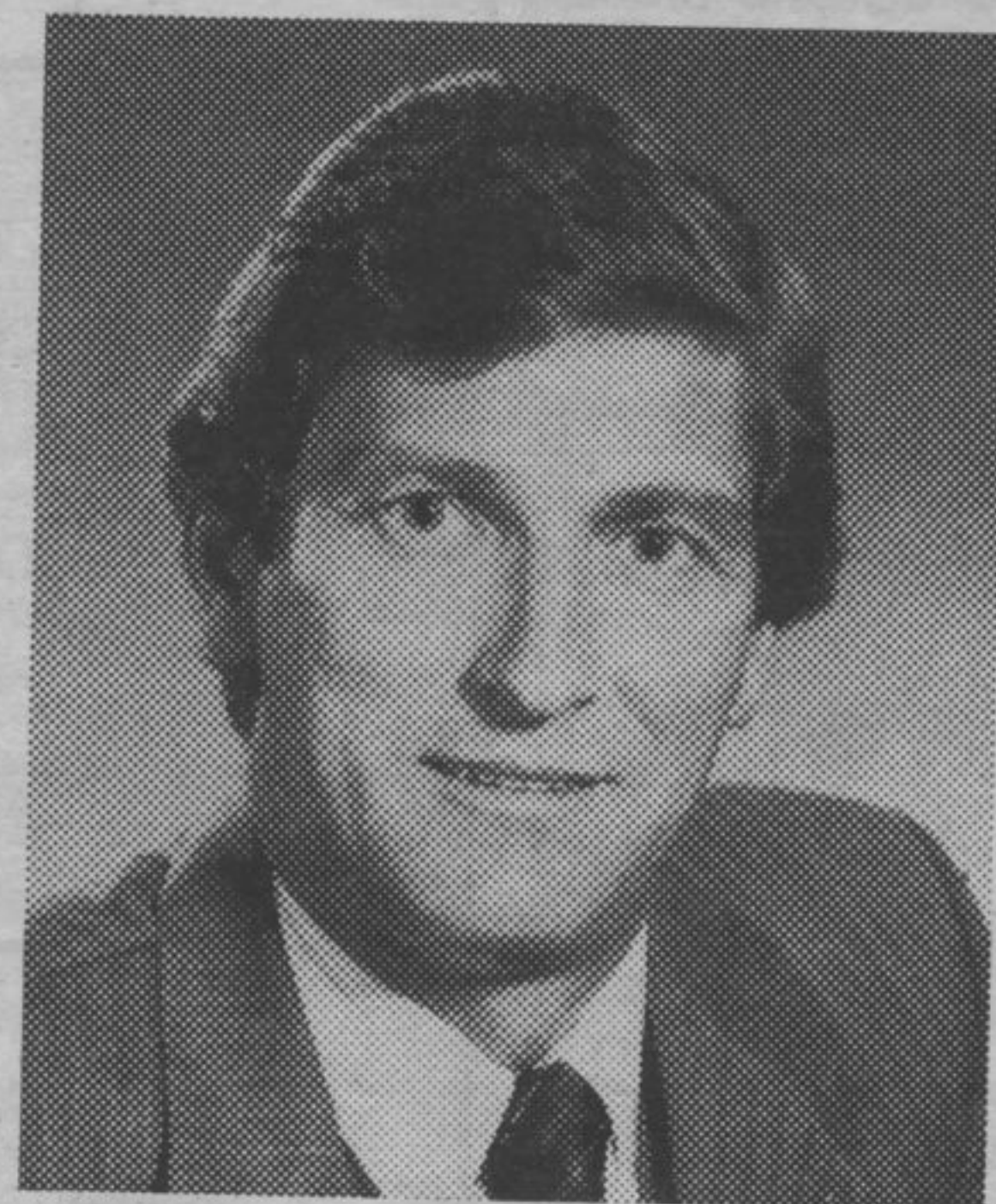
