Zoning by-law 88-5

TAKE NOTICE: That the Council of the Township of Schreiber passed By-Law 88-5 on the 8th day of March, 1988, under Section 34 of the Planning Act, 1983.

AND TAKE NOTICE: That any person or agency may appeal to the Ontario Municipal Board in respect of the by-law by filing with the Clerk of the Corporation of the Township of Schreiber, not later than April 12, 1988, a notice of appeal setting out the objection to the by-law and the reasons in support of the objection.

An explanation of the purpose and effect of the by-law, describing the lands to which the by-law applies, and a key map showing the location of the lands to which the by-law applies (or, alternatively, an explanation as to why a key map is not provided are attached. The complete by-law is available for inspection in my office during regular office hours.

Dated at Township of Schreiber, this 14th day of March 1988.

No map is provided because, the main object of the by-law is to include the operation of a convenience store and laundromat in the Highway Commercial Zone, which applies to all properties on that zone. The minimum rear yard allowance is increased to 3 meters, on Lot 68 only, (Superior Shell) and will be subject to site plan control.
