# Nothing lasts forever

A Notice of Termination from a tenant to a landlord or their agent can be delivered personally or sent by regular mail. If the notice is sent by mail, the Landlord and Tenant Act assumes it is delivered on the third day after mailing. A notice from the tenant must be given to the landlord 60 days before the last day of the final month of tenancy, for weekly tenancies at least 28 days before the final day of the final week of tenancy or for fixed tenancies, at least 60 days before the last day of the tenancy.

In the case of a Notice of Termination from a landlord to a tenant, the landlord must attempt to

deliver the Notice personally. If the tenant is away or avoiding notification, the landlord can hand the notice to a person in the dwelling if the person appears to be over the age of 18. The landlord may also post the notice is a conspicuous place in dwelling, or send the notice by registered mail.

If a notice from a landlord or tenant is late — even by one day — it is not valid and must be given again with the same previous time limits applying.

The Landlord and Tenant Act allows a landlord to terminate a tenancy only for certain reasons. The reasons for termination must be stated in detail in the landlord's Notice of Termination.

A landlord may terminate a tenancy before the agreement ends for any of the following reasons; failure to pay rent, undue damage, disturbing others, overcrowding, impairing safety, illegal acts, misrepresenting income in Public Housing. A landlord can also terminate a tenancy at the end of an agreement for any of the above reasons and also for the following; landlord's own use for accommodation of immediate family — for self, children or parents, for persistent late rent, ceasing to qualify (subsidized housing), demolition, renovation, conversion or major repairs, or failed condominium sale.

In all cases, proper notification must be given — please refer to Guide to Landlord and Tenant Act.

In many cases, landlords and tenants are not aware of their rights and obligations. By acquiring some basic knowledge of the Act, tenants and landlords can avoid a lot of pit-falls and unpleasant situations.

Educate yourself — read the Guide to the Landlord and Tenant Act.


