## Police seek assistance to solve thefts

During the fall of 1987, two separate businesses in and near the village of Upsala were to victims of break an enters and a great deal of merchandise was stolen.

On the weekend beginning Oct. 17, the Happy Traveller Restaurant on Highway 17 within the village of Upsala was entered. Entry was gained by moving a large window which measures 4 feet by 5 feet past the lock.

The then entered the business. Once inside, 50 cartons of assorted brands of cigarettes were stolen, as well as three pairs of leather gloves, one blue flashlight and six packages of size D Everready batteries.

Once inside, a number of pelts were stolen including six sheep pelts, six beaver pelts, six caribou pelts, one wolf hide and one large moose hide. Also stolen was a large quantity of sweat shirts and T-shirts in various sizes and colours.

Some of the sweat shirts had pictures of loons on the left top area, while some were marked "Lac Des Mille Lac." Others had pictures of fish or bears. The majority of these are pink in colour, while some were gray, white, navy or light blue. In total, 65 sweat shirts, some of which have hoods, were stolen.

To date, no arrests have been

made in either occurrence, nor has any property been recovered. Both businesses have made modifications to their buildings to guard against future break-ins of this nature.

Crime Stoppers will pay up to \$1,000 this week for information leading to the arrest of the person responsible for these crimes.

## Provincial Court Report

Provincial Court was held on Sept. 21, 1988. There was a full docket, and court lasted almost two hours. Several trials were held.

Calvin Jalbert, formerly of Schreiber, was found guilty on a charge of driving a motor vehicle while it was not insured. The mandatory fine was \$503.75. Jalbert was also found guilty of driving a motor vehicle while suspended. The fine was \$1,003.75.

Two other non-residents were convicted of driving while their licences were suspended. Each was fined \$253.75.

Ministry of Natural Resources officials laid several charges under the Ontario Fisheries Regulations for snagging fish.

Art Stachiw of Terrace Bay plead guilty to snagging pink salmon and was fined \$103.75.

Richard Roy and Joseph Roy were charged with possession of pink salmon. Each was fined \$153.75. Their equipment was seized, and it will not be returned.

There were several other charges and convictions at court for minor offences.

1) Provincial Court is held on different dates than Criminal Court. In Schreiber, both are held at the Legion Hall on Winnipeg

2) A Justice of the Peace presides over Provincial Court. A Judge presides over Criminal Court.


3) Provincial Court covers Provincial Statutes; Criminal Court covers Federal Statutes, e.g. Criminal Code of Canada.

Provincial Court deals with minor offences like speeding, liquor violations, driving while suspended. It also deals with all town by-laws.

Criminal Court deals with major crimes like assault, impaired driving, fraud, and theft.

Next Criminal Court is Oct. 5, 1988 at 10.30 a.m.




