The program will begin on Wednesday, January 25 and Saturday, January 28. Drop in and pre-register.



FREE TRADE AND THE TRAVELLER

The Free Trade Agreement will gradually eliminate customs duty between Canada and the United States.

Some things change:

- The duty on some Free Trade goods will be eliminated immediately while the duty on other goods will be phased out in stages.
- Only goods which are of U.S. or Canadian origin will be eligible for lower Free Trade Agreement duty rates.
- The goods must have been acquired in the U.S. and must have no mark or label indicating the goods were produced in any country other than the U.S. or Canada.
