

Terrace Bay Council

At the July 10 council meeting, Freda Boucher and Mac Rogerson, speaking for themselves as well as other residents, expressed concerns regarding the retaining wall and sand in the back yard of 230 MacDonald Ave.

They feel the situation is unsafe and is also lowering surrounding property values. They requested council do something to remove the retaining wall and landscape the yard, but Clerk/Treasurer/Administrator Dave Fulton explained there are no laws that give council the authority to act in this matter because it is private property.

Council discussed the matter and contacted the Bank of Montreal (the

owners of the property) to see what could be done.

It was reported at the July 24 council meeting that, following discussions, the bank appears willing to cooperate if the cost is reasonable. Council is getting some price quotes for getting the property back into acceptable condition.

Council is acting as a liaison and won't be actually contracting the work to be done, but will give the quotes to the bank which will then decide what course of action to take.

Council will be suggesting the Thunder Bay District Homes for the Aged Master Plan meeting, original-

ly scheduled for early September, be postponed until later in the month or for early October. They feel this will give them sufficient time to review their position.

A special \$300 donation was made to the Northshore Family Resource Centre by council.

Council received a note of thanks from Lake Superior High School. Both Terrace Bay and Schreiber Councils purchased corsages and boutonnieres for the graduating students.

Council received information passed on from the Terrace Bay Police from Debbie Hamelin.

Hamelin is working with the Victims of Violence Resource Centre to bring about changes to the Young Offender's Act. Hamelin's two-year-old daughter, Chantelle, was murdered by her 14-year-old baby sitter. The young offender now faces a maximum three-year jail term.

Hamelin has sent a petition to council, and this petition will be available for anyone to sign at the municipal office. (For the full story see page 8).

Council has decided to take part in the Aguasabon Chamber of Commerce Trade Show being held

Sept. 15 and 16, 1989. The various studies that have been conducted, other activities of council, and councillors will be on hand for the public.

A by-law regulating the planting and removal of trees was passed by council. The by-law applies to trees growing on any highway or public lands within the Township of Terrace Bay. Such trees may not be removed, trimmed or destroyed without the prior written authorization of the Township Engineer. Any person convicted of breaching this by-law is liable for a fine of up to \$2,000 per tree.

Commission of Inquiry Into the Relationship Between Certain Individuals and Corporations and Elected and Unelected Public Officials

NOTICE

This Inquiry has been constituted pursuant to Order-in-Council dated July 6, 1989, pursuant to the provisions of the Public Inquiries Act, R.S.O. 1980, chapter 411:

- (1) to investigate:
 - (i) the nature and extent of the dealings between Patricia Starr and elected and unelected public officials;
 - (ii) the nature and extent of the dealings between Patricia Starr and private individuals, corporations, unincorporated bodies and charities in relation to elected and unelected public officials;
 - (iii) the nature and extent of the dealings between Tridel Corporation; companies related to Tridel Corporation; representatives, officers, employees or officials of Tridel Corporation; representatives, officers, employees or officials of companies related to Tridel Corporation, and elected and unelected public officials;
 - (iv) the nature and extent of the dealings between Tridel Corporation; companies related to Tridel Corporation; representatives, officers, employees or officials of Tridel Corporation; representatives, officers, employees or officials of companies related to Tridel Corporation and private individuals, corporations, unincorporated bodies and charities in relation to elected and unelected public officials.
- (2) to inquire into and report upon any such circumstances or dealings where, in the opinion of the Commissioner, there is sufficient evidence that a benefit, advantage or reward of any kind was conferred upon an elected or unelected public official or upon any member of the family of any elected or unelected public official, or where, in the opinion of the Commissioner, there is sufficient evidence that there was any agreement or attempt to confer a benefit, advantage or reward of any kind upon an elected or unelected public official or upon any member of the family of an elected or unelected public official.

And that nothing set out above shall be taken as in any way limiting the right of the Commissioner to petition the Lieutenant Governor in Council to expand the terms of reference to cover any matter that he may deem necessary as a result of information coming to his attention during the course of the investigation or inquiry.

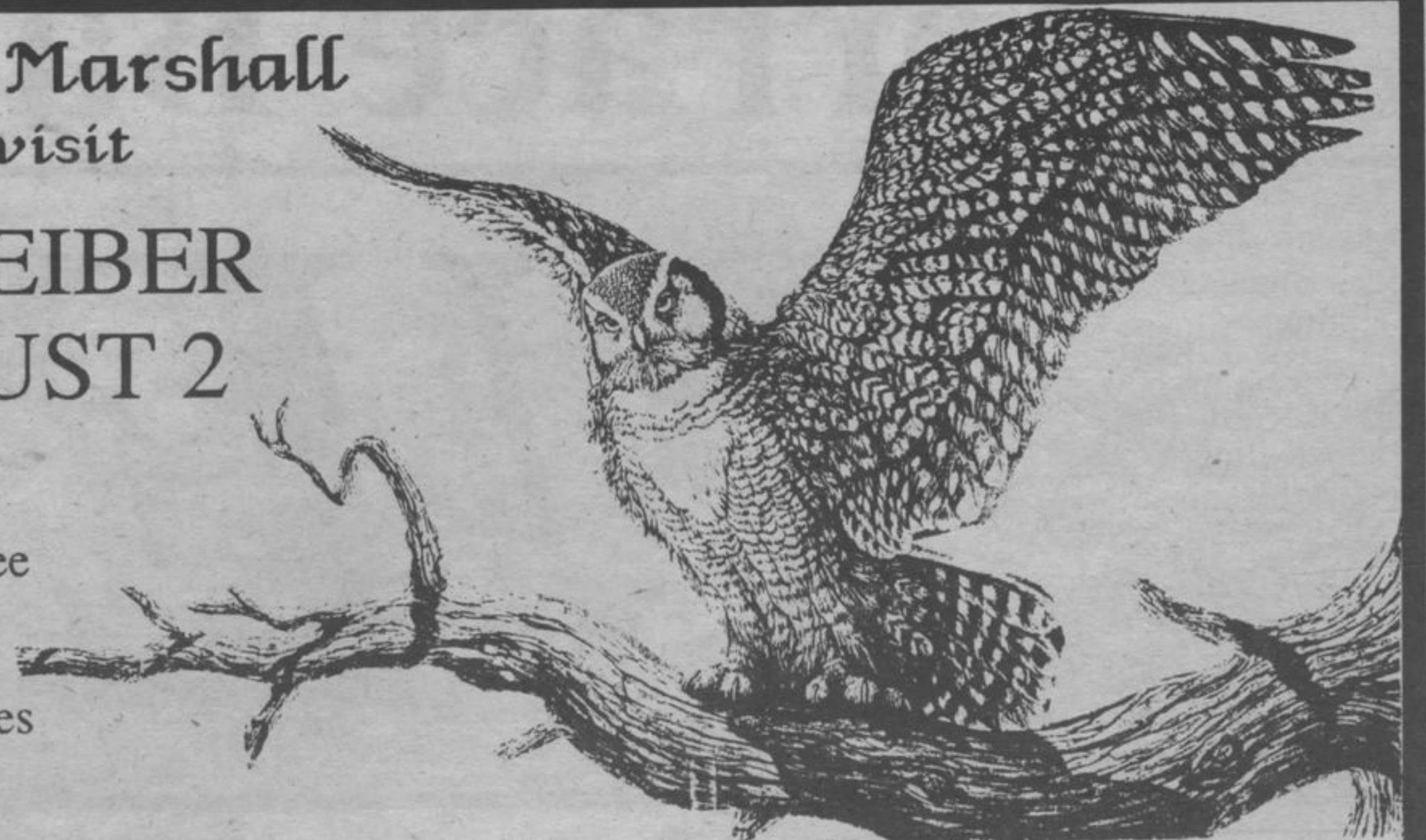
