Criminal Court Report

Criminal Court was held on Wednesday, August 23, 1989, at 10:30 a.m.

The following convictions were registered.

Victor J. Berzins of Barrie, Ontario, pled guilty to an Impaired Driving charge. He was fined \$300 and given a one year licence suspension. At the time he was found to be driving while impaired - he was also under suspension from driving. He was given a \$253.75 fine for driving while under suspension.
