### CWL petitioning government

Following the reconvening of Parliament September 25, women across Canada are being invited by the Catholic Women's League to demonstrate their support for federal pro-life legislation.

In the largest initiative of its kind, the Catholic Women's League of Canada (CWL) has written to each of its 124,000 members asking them to sign a petition entitled "Women - Sign for Life:. The letter also urges members to invite other women with similar views to sign the petition.

This action was taken as a result of a resolution passed unanimously at the League's 69th National Convention in late August.

National President, Evelyn Wyrzykowski says, "this is a unique opportunity for Canadian women who value and respect human life at all stages of development, to make their voices heard by our government, loudly, clearly and in great numbers. We hope that they will take this opportunity to speak with a united voice on this important issue."

She adds, "this is the most aggressive pro-life initiative we have ever taken, and the CWL is inviting all women who value life to put their feelings on record. We must let our politicians know where we stand and that vocal women's groups who call for abortion as a woman's right, do not speak for all the women of Canada."

It is anticipated that the petition will be presented to government in early November.

# Preparing your dog for the cold winter months

Some of you may remember this column from last year, but I feel it is worth repeating.

The weather during the last week has reminded us that winter will soon be here.

Now is the time to prepare your dog for the cold weather.

Decide now if your dog will be an outdoor or indoor dog. A half-and-half routine is more

difficult on your pets system. When a dog is left out only during the day it is impossible for him to develop the good winter coat that is needed to cope with the stress of winter temperatures.

You can leave your dog outside if it is a warm and sunny day and bring him back in during the late afternoon.

Young puppies, older dogs, toy breeds or shortcoated dogs, such as Dobermans, toy poodles, are not suited to be an outdoor dog.

Alaskan Malamutes, Siberian Huskies, or any type of dog that grows a thicker coat, enjoy the outdoor life and will find our heated homes too warm.

Salt, snow and ice can be tough on tender foot pads, so check their feet often.

Housing should be given top priority when you have an outdoor dog. The house should be dry, insulated, and of the appropriate size.

It should be large enough to allow the dog to turn around and stand. If the house is too large, it

will cause the dog to lose important body heat.

Use straw or cedar chips to help give your dog an extra factor of insulation if there is no other type of insulation.


