# Angered by cuts, Schreiber, Terrace Bay will fight gov't

announced, Terrace Bay Reeve Jim Ziegler called other reeves and mayors along the North Shore to organize a meeting to discuss ways to fight the cuts.

He said no date has been set yet for the meeting and is unsure whether action will proceed through the Northern Ontario Municipal Association (NOMA), or the communities affected by the cuts.

"We're trying to build the tourism in this area and a scenic ride on the train along the North Shore really helps," said Ziegler.

He commented on the VIA cuts that came despite wide ranging criticism from Canadians.

"It's frustrating. Most Canadians seem to be against the cuts. Isn't the government supposed to represent the people?"

He said Terrace Bay Council will be talking with the local MPP and MP to voice the community's opposition to the cuts.

Ziegler added, "the govern-

ment never kept the system up. It's their doing that caused this. I really feel the government let the service drop to a point where it will cost so much money to bring it up to snuff, they feel justified in making the cuts."

Cosgrove echoed Ziegler's sentiments saying, "they don't want the business. The government can't run itself - they sure can't run a private business."

The day the VIA cuts were made public, the federal government announced a Royal Commission will be formed to examine passenger travel service in the next century.

Whether Terrace Bay or Schreiber will take part in these hearings is uncertain at this point, but the two communities will be taking action to oppose the VIA Rail passenger service cuts, and to try to have the service reinstated along the North Shore.

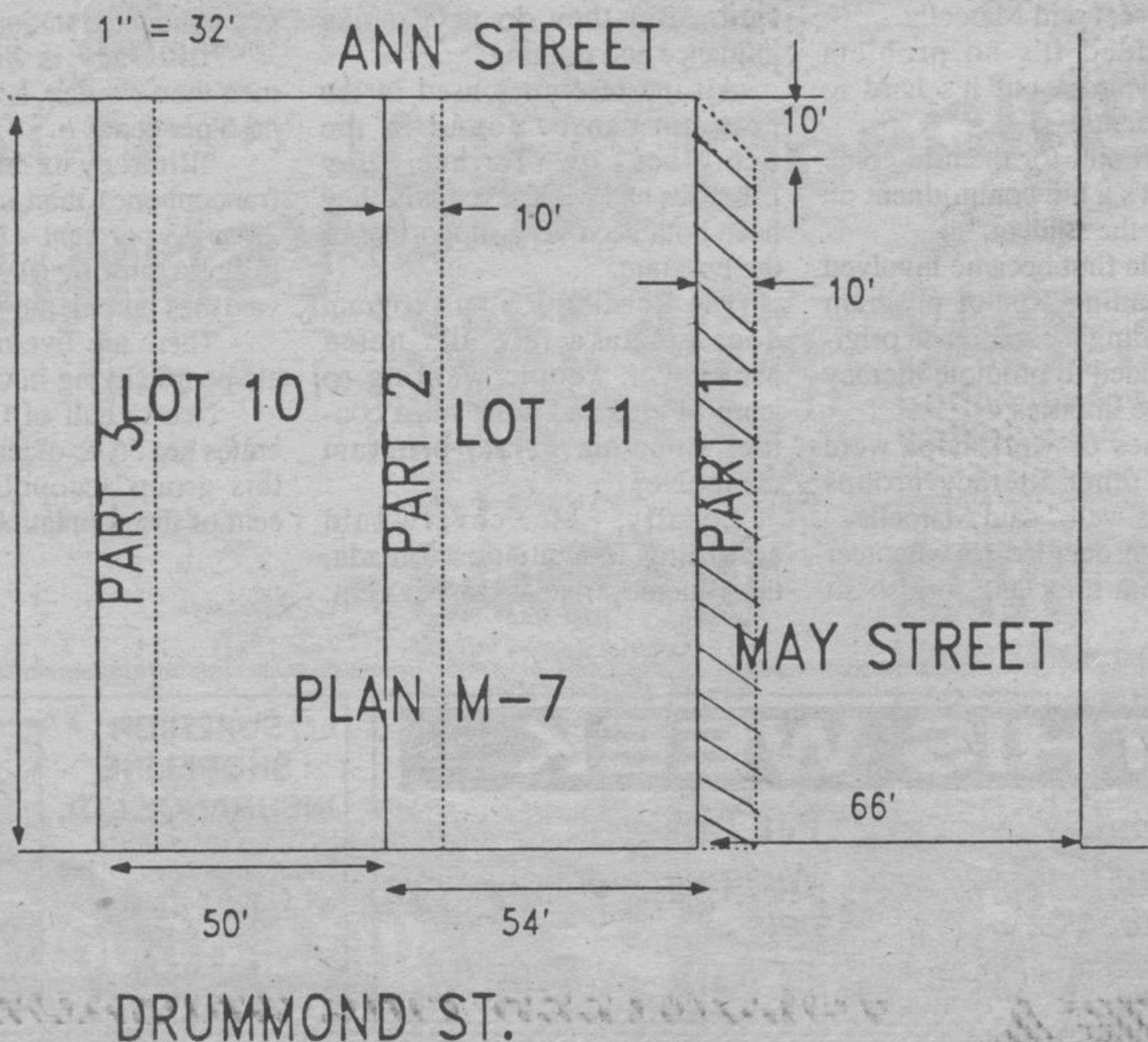
A By-Law to stop and close part of a public street or highway more particularly described as follows:
