

Criminal Court Report

Judge Clarke presided over a lengthy court docket on Nov. 15, 1989. Most issues were remanded until January and February court dates.

Burton Borrie of Terrace Bay pled guilty to a charge of Failing to Provide a Breath Sample. He was given a \$300 fine and prohibited from driving for one year.

Randall Gladu of Terrace Bay pled guilty to Assault Causing Bodily Harm. He was given a \$500 fine and placed on probation for 12 months. Gladu is to abstain from alcohol for a period of 12 months.

Above charges were laid by the Terrace Bay Police Force.

Next criminal court will be held January 10, 1990.

Provincial Court Report

Provincial Offences Court was held on Nov. 22, 1989 in Schreiber.

Wilber Bain of Schreiber pled guilty to Failing to Remain at the Scene of an Accident and was fined \$153.75.

James Callaghan of Terrace Bay was found guilty of three Highway Traffic Act offences. He was fined \$53.75 on each charge.

Herman Winter and Emilio Ciampa were found guilty of a Ministry of Natural Resources charge of not affixing a tag to the moose which they had shot. They were fined \$250 each and the moose carcass was confiscated.

Minnova Inc. pled guilty to 10 Highway Traffic Act charges and were given a \$53.75 fine on each charge.



A snowmobile safety course was held for youths aged 12 to 16 last week in Terrace Bay. Terrace Bay Police Constable Wes Fenton, with the help of MNR Conservation Officers Paul Dennis and Mike Kenney taught the course to 20 kids.

Issues such as safety, attitude, snowmobile operation, respect of personal property and survival were some of those covered.

Fenton said safety and knowledge of the law were stressed over the week long course. Exams were held late in the week with graduation taking place at the Terrace Bay Recreation Centre Monday night. A mark of 75 per cent was needed in order to obtain an operators permit.
