Studys show an investment in the community

You will recall the events of 1986 that led the current Reeve & Council to Campaign & be elected on a platform of Economic Diversification. You, the voters, gave these gentlemen that man date.

Since the election, Council has undertaken a number of studies that would improve the natural assets of the community & lead to economic diversification

The latest study is a tourism development strategy which identifys Terrace Bay's Tourism potential over the next 10 years. The first phase of the study recommends among other things, the construction of a Tourist Reception (information) Centre. The capital cost is estimated at \$358,500.00 for 1990. Of this

amount the province will fund \$278,000.00 leaving the municipal share of \$80,500.00. Simply speaking it means a maximum residential mill rate increase of 1.86 (\$19.00 average) and a Business/Commercial Mill Rate increase of 2.13. We, the Tourism Development Strategy Committee, feel that this is a good investment in the community and we ask you, the community, to show council positive support for this project. This is the final year of the Provincial Funding Programme for construction purposes and with the 7% Goods & Services Tax coming effective in 1991 it is imperative that Council submit a request to the provincial government for the 75% funding as soon as possible.

The Terrace Bay - Schreiber News has agreed to publish further articles on this strategy and

the committee plans to hold a Public Meeting (as required in our terms of reference) time, & place to be announced. Questions or concerns should be directed to the undersigned, and thank you for your interest and support.

When approved, these rates will be reflected on all hydro bills issued after March 1, 1990 for all electric customers and April 1, 1990 for residential customers. This increase covers consumption of electricity after the date of January meter reading.

The above rates reflect an overall 6.4% rate increase over 1989 levels.
