# TOWNSHIP OF SCHREIBER NOTICE MUNICIPAL ELDERLY RESIDENTIAL ASSISTANCE ACT

In order to determine the number of owners of residential property who may be eligible to receive a property tax credit (amount yet to be determined), the Township Council is requesting that any property owner, who is interested in obtaining information concerning the credit may do so by completing a form available at the municipal office.

To be eligible to receive the grant you must:

- 1. Own residential property in Schreiber, that is to say, be an assessed owner for at least one year.
- 2. As an owner, you or your spouse, have attained the age of sixty five years.
- As an owner, you or your spouse, are in receipt of a monthly guaranteed income supplement under the Old Age Security Act (Canada).




