Bell has some big plans for Terrace Bay and Schreiber

TERRACE BAY -- Bell Canada plans to spend about \$150,000 in capital expenditures on upgrading transmission facilities and other service improvements for the 1,039 customers in the Township of Terrace Bay during 1990. Some of the major projects included:

- installing additional switching equipment to meet growing demands.

- installing additional transmission equipment.

"This investment in Terrace Bay is part of Bell's total \$2.4 billion construction program for 1990," said Georgie Hari, Bell's local manager. She added that Bell is substantially increasing its investment to modernize the network. "This will help make us more efficient and contribute to keeping the rates down."

As well, in 1989 Bell paid \$59,269 in municipal taxes to Terrace Bay, including \$1,632 in realty taxes, \$490 in business taxes and \$57,147 in Gross Receipts taxes.

The Gross Receipts tax is set at 5 per cent of all telecommunications revenue from Bell operations in Ontario during the preceding year. The amount allotted to each municipality is based on the number of Bell telephones installed. In 1989, this tax was \$30.35 per telephone.

In addition, Bell spent a total of \$2.3 billion on capital

improvements in 1989, of which \$1.5 billion was spent in Ontario. The company expects its capital program in 1990 will involve \$2.4 billion, with \$1.6 billion being spent for customers in Ontario.

Bell Canada has made an environmental commitment to Terrace Bay and other communities throughout Ontario. The company has implemented an internal recycling program, a purchasing policy which encourages use of recycled products and, through its subsidiary TeleDirect, is publishing telephone directories which are readily recyclable.

Bell Canada, the largest Canadian telecommunications operating company, markets a full range of state-of-the-art products and services to more than six million business and residence cus-

tomers in Ontario, Quebec and parts of the Northwest Territories.

SCHREIBER -- The installation of additional transmission and switching equipment and other service improvements accounted for \$940,000 in capital expenditures last year for Bell Canada's 980 customers in the Township of Schreiber.

In addition, Bell paid about \$47,621 in 1989 in municipal taxes to Schreiber, including \$6,733 in realty taxes, \$2,567 in business taxes and \$38,321 in Gross Receipts taxes.

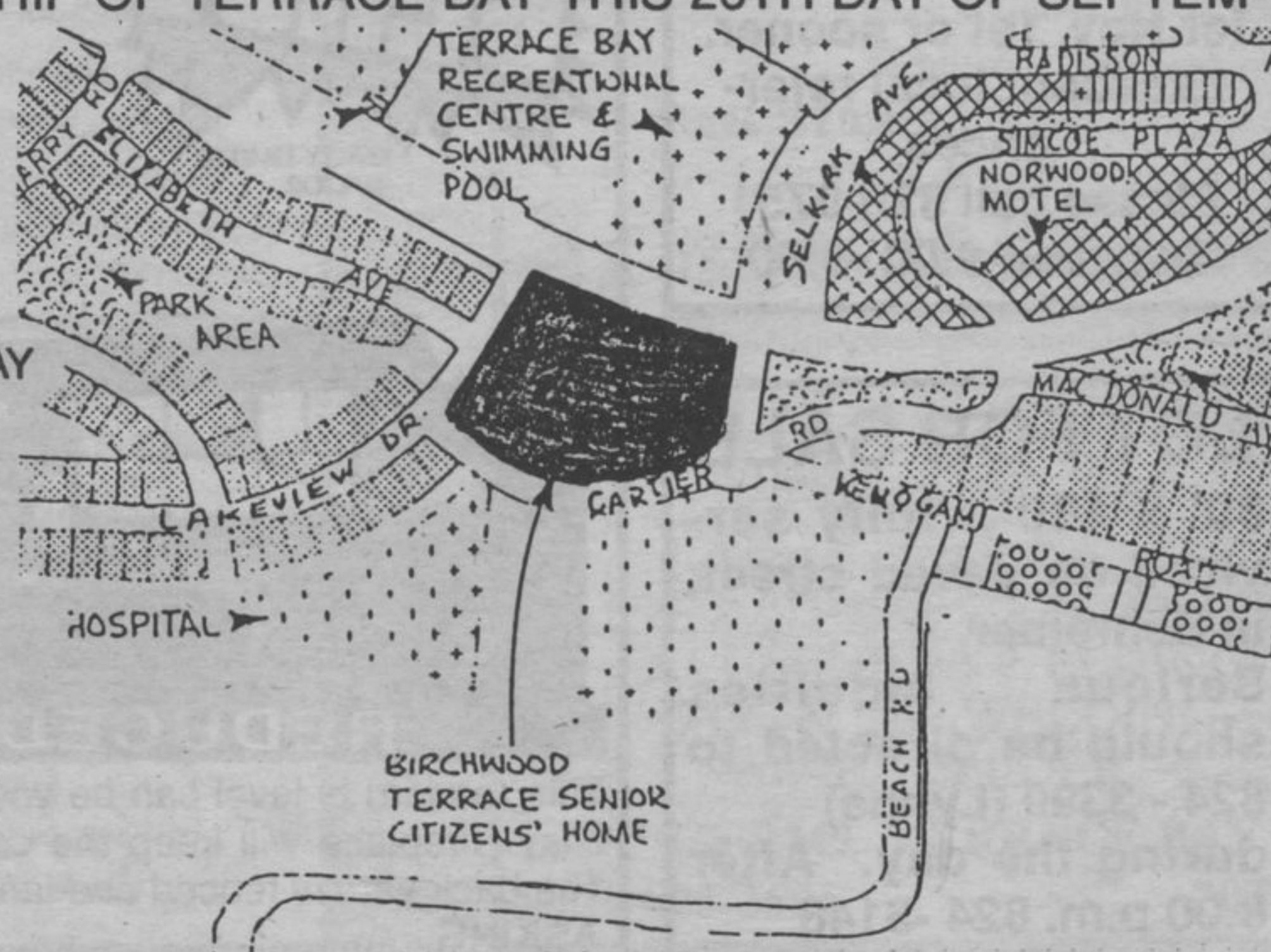
The proposed zoning by-law amendment would add "professional office" as a permitted use in Birchwood Terrace, Thunder Bay District Homes for the Aged.
