TAKE NOTICE that the Council of the Corporation of the Township of Terrace Bay passed By-law No. 26-90 on the 24th day of October, 1990, under section 34 of the Planning Act, 1983.

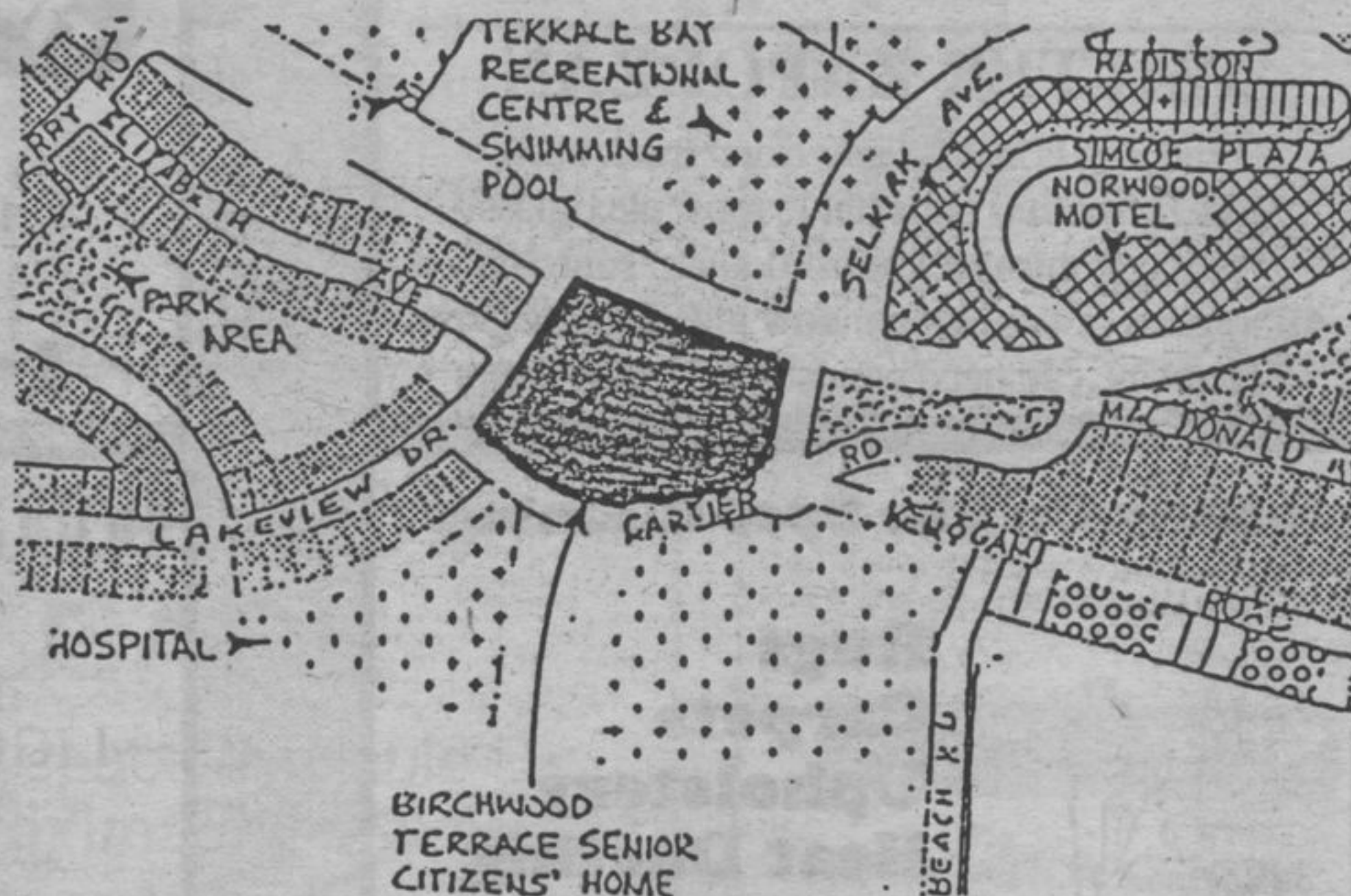
AND TAKE NOTICE that any person or agency may appeal to the Ontario Municipal Board in respect of the by-law by filing with the Clerk of the Corporation of the Township of Terrace Bay not later than the 19th day of November, 1990, a notice of appeal setting out the objection to the by-law and the reasons in support of the objection.
