

Christmas crafts for kids

Almost everyone likes to experience that feeling of accomplishment that comes only from creating something with your own hands.

Children are no exception. There is no greater joy than seeing a child filled with pride over something they made. Now is the time of year to make crafts a family event and share in that joy.

SAUCY SANTAS

Materials

Red Construction paper
White typing paper
Red felt-tip marker
Black felt-tip marker
Red thread
White craft glue
Clothespin
needle
geometry compass

Method

- Using compass, draw a 29cm (11 1/2 in.) diameter circle on red construction paper. Cut it out. Cut circle into 4 equal pie-shaped wedges.
- Using photo as guide, cut a Santa face and beard from white paper. Draw eyes, mouth; glue to center of one wedge.
- Roll up sides of wedge to form a cone, overlapping edges 13mm (1/2 in). Glue in place. Hold together with clothespin until gluedries.
- Thread a loop of red thread through tip of cone. Make Santas from 3 remaining wedges in same manner.

GST?

Q: I'm thinking of buying a new car in 1991. How will the proposed GST affect prices?

A: The outgoing Federal Sales Tax (FST) is now part of the price of new cars. So, while they will be fully taxed at 7% in 1991, the expected effect of replacing the FST with the GST on the average \$22,000 mid-size car is a reduction of around \$850.

Q: My son has figured out it will cost \$500 in lumber to build a dock at our cottage if he bought it now. How much will that lumber cost with the proposed GST?

A: You can expect to pay about \$512 for that same amount of lumber for personal use based solely on the changeover from the FST to the GST.

Q: I know the proposed GST won't apply to city bus fares but I take the commuter train to work. Will I have to pay GST?

A: No. Daily commuter trains are considered a municipal transit service, so fares are exempt from GST.
