
The old coils were removed, the stator cleaned and routine maintenance and minor repairs were undertaken.

The new coils were installed by manufacturer General Electric.

Ontario Hydro electrical and mechanical crews are currently reassembling the unit which should provide reliable generation for another 40 to 50 years.

The low water flow during mid-winter provides efficient conditions for the shutdown of a unit in this two-unit, 40,000 kilowatt, generating station.


The project will cost approximately \$500,000.


Project 'A' - From 1.9 kilometres East of the Township of Schreiber West Limit Easterly for 16.5 kilometres

Project 'B' - From 0.6 kilometres East of the CP Rail Overhead Structure in the Township of Terrace Bay Easterly for 17.0 kilometres

The Ministry of Transportation, has initiated two studies to examine potential improvements to Highway 17 from 1.9 kilometres east of the Township of Schreiber West Limit Easterly for 16.5 kilometres and from 0.6 kilometres east of the CP Rail Overhead Structure in the Township of Terrace Bay easterly for 17.0 kilometres.

The proposed work will include the elimination of frost heaves and pavement distortions, improvement to the riding quality of the driving surface and rehabilitation of the shoulders. Realignment of Highway 17 at three separate locations is proposed to improve traffic service and safety on this section of Highway 17. The urban sections in Terrace Bay and Schreiber will be reconstructed and paved.

These studies will follow a Class Environmental Assessment process approved for highway projects of this type. Upon completion of the studies, Environmental Study Reports will be available for public viewing. A further public notice will be published at that time.
