



The press release pointed out that the reorganization has increased the job description of a 62 year old woman employee. Her duties will now include snow shoveling and ice removal. If she finds that during the winter of 1991 she is unable to perform her new duties because of her age, she would be terminated.

Cancade said, in the press release, that there are other employees who feel they have been unfairly dealt with.

Cancade also said he has

just recently been put into possession of a document which appears to be the Constitution of the Labour-Management Committee.

It is his opinion that the provision for calling special meetings at "any time by anyone on the committee within three days notice" has been breached by the administration.

The employees have taken every step to deal with the problems on a strictly internal basis, the release said, and management's choice to ignore

labor's concern, has left them no choice but to seek the intervention of the Board of Management of the Thunder Bay District Homes for the Aged and the provincial ministers responsible for funding the institution.

The employees have informed Gilles Pouliot, MPP Nipigon of the situation and say that he referred the matter to Bob MacKenzie, labour minister for Ontario requested a more fair and equitable solution be sought.
