

The North of Superior District Roman Catholic Separate School Board on the 14th day of March, 1991 passed By-Law Number 91-1 to authorize the borrowing of money by the issue and sale of debentures of the said Board in the principal amount \$279,000.

1. The purpose for which the money is to be borrowed is for the construction of an elementary school in Marathon, the purchase of furniture and equipment, and the construction of an addition to Holy Angels School in Schreiber and the purchase of furniture and equipment.

2. The amount to be borrowed is \$279,000 for 20 years on the security of the said debentures, which shall be a charge upon the schoolhouse property and premises and any other real or personal property vested in the said Board and upon the separate school rates collectible by the said Board.

3. The Debenture is to be dated the 10th day of April and shall be payable in one installment of principal on the 10th day of April in the year 2011. On presentation and surrender of this Debenture, the principal sum of Two Hundred and Seventy Nine Thousand Dollars (\$279,000) and will pay interest on the said principal sum, in like money from the 10th day of April 1991 at the rate of 10.01% per annum payable semi-annually on the 10th day of October and the 10th day of April in each year of the currency of this Debenture.
