# Conviction overturned

A Terrace Bay police constable has successfully appealed his conviction on charges of common assault while on duty.

Constable Glen Krentz was sentenced last March to 14 days in jail after an incident involving Melody Mateev, of Terrace Bay, on Aug. 4, 1990.

Krentz was suspended from the force for a week, but still retained his Constable First Class designation.

He immediately appealed his assault conviction, and it was overturned in Thunder Bay District Court Sept. 25.

"It's long overdue," Krentz said Friday, adding he never had any doubt he would be aquitted.

Melody Mateev said Friday she didn't know if she could take further action against Krentz, but she's glad he didn't go to jail.

"I had to fight for what I believed in," said Mateev.
