
ONTARIO GOVERNMENT NOTICE

Environmental Study Report Submission
Whitesand River Channel Diversion
(Lakeshore Drive)

The Ministry of Transportation (MTO) has completed a study that will result in the realignment of the Whitesand River where it abuts Lakeshore Drive in the Township of Killraine.

The Ministry's plans call for the realignment of a 60 metre length of river to one of its original channels, approximately 35 metres northwest of its present location. The purpose of this work is to reduce the risk of road washout along Lakeshore Drive.



This study followed a Class Environmental assessment process approved for projects of this type. As required by this approval, an Environmental Study Report has been filed with the Ministry of the Environment (MOE) and is available for public review at the following MOE Offices:

Health group is seeking tougher anti-smoking laws

The National Non-smoking Week Committee - Thunder Bay, a coalition of local health and human services groups and concerned citizens, today supported a province-wide campaign entitled "Give Kids a Chance", aimed at preventing the tobacco industry's continued access to the children's market.

"More than 13 thousand Ontarians dies each year from tobaccos use," says Dr. David Williams, Medical Officer of Health.

"At the Thunder Bay District Health Unit, we believe that new and enhanced health promotion strategies are needed to meet the needs of the people who have not yet reached effectively by existing programs.

"We agree that the tobacco use situation in Ontario is urgent, but contend that it is even more urgent in the District of Thunder Bay. Our adolescent population may smoke as much as twice as much as the provincial average, yet do not consider smoking as an immediate health problem."

"We are calling for tough measures," said Ludovic D' Souza, Executive Director of

the Council for a Tobacco-Free Ontario.

"But every measure is based on common sense, and is proportional to the seriousness of the epidemic. Any Minister of Health who explains to the public—yes, even to smokers—that these measures are designed to keep kids away from a lethal, addictive product, and that they are fighting for kids, will carry public support."

The "Eight Prescriptions for Health" sought by the health groups, include plain cigarette packages with strengthened health warnings to reflect the fact that cigarette packages contain a lethal, addictive product, and a provincial tobacco retailer licencing scheme that would involve the revocation of licences of those retailers caught selling to minors.

"Several measures can be implemented at the community level," said D' Souza.

"Local health groups can call upon municipal governments to guarantee public health and safety through bylaws that prohibit smoking in all indoor public environments and workplaces.

"Similarly, municipal licensing of tobacco retailers can provide for stronger enforcement and health education opportunities at point of purchase."

The National Non-smoking Week Committee is committed to working in Thunder Bay and District on these issues, said Lori Chow, chair of Thunder Bay's National Non-smoking Week Committee.

"As we grow and develop into these areas, we welcome individuals and groups to join us in our efforts."

D' Souza said there is at least one reason for separating tobacco industry products from other legal products, and for giving cigarettes special treatment: tobacco products are the only products that kill the user when used exactly as the manufacturer intends.

He also urged citizens in Thunder Bay and area to write their provincial representatives in Parliament to support this campaign.
