

Scout camp becoming a reality

The way Dave Kaizer figures it, the cub scout camp he and a host of volunteers are

building would cost about \$100,000 if they had to pay market prices for materials and labour.

As it is, the camp will cost

around \$50,000, and almost half of that—\$22,500—is being provided through a Ministry of Tourism grant.

The group has raised their share of the money through cheese drives, dances, investments, and through donations of time and money.

Construction of the camp, which is located on Whitesand Lake, began in spring, 1991, and will be more or less completed sometime this winter.

It will sleep 18, and other service clubs, such as girl guides and brownies, will also be able to use it.

"Dave managed to get some pretty good deals (on materials)," says Scout Treasurer Karen Ramsay.

Kaizer, who's the chairman of the Terrace Bay Scouts, says the camp took shape gradually.

"We more or less designed it as we went along," he says. And not only did they design it themselves, with only a few exceptions, the volunteers built them selves, including doing the carpentry work and the mortaring.

In addition to Ramsay and Kaizer, other volunteers include Richard Saindon, Schreiber Chairman; Len

JAIL & BAIL

The McCausland Hospital, in conjunction with the Terrace Bay, Schreiber Lions Club, are planning a **JAIL & BAIL** fundraising event. The proceeds will be used towards the purchase of "Freddie the Fracture Finder", X-ray machine, for the McCausland Hospital.

What is a JAIL & BAIL? Persons from within the communities of Schreiber, Terrace Bay and Rosspoint are charged with a fictitious offence. They are served with a summons to appear in a mock court, in answer to the charge. Prior to appearing in court, the accused is given a set fine, i.e. \$100. It is the responsibility of that person to raise this amount of money from friends and relatives before the court appearance. The accused will bring this money to court on September 26, 1992. In the event that the accused was unable to earn this amount of money, he/she will then have a mock trial. The accused is then provided with a telephone from within a jail cell, and will attempt to raise his/her bail.

The JAIL & BAIL will be held at the Terrace Bay Curling Club on September 26, 1992 from 9:00 a.m. until 6:00 p.m. The accused will appear in court at this time. A jail cell, a court room, a judge, prison clothes and a spectators area will be set up. All monies pledged by an individual will receive a taxable receipt. Our local TV, channel 13 in Terrace Bay will be covering this event.
