66 council meetings produce 87 by-laws

Milton councillors received a special thanks from Mayor Gord Krantz last week as the local council met for the final meeting of the year

'We have a list of achievements that council should be proud of. It keeps growing because councillors keep accomplishing more, 'said the Mayor.

In presenting a year end wrap-up of the activities in 1984, Town Administrator Roy Main noted that local council had convened a total of 66 times for various council and committee meetings.

During the past year Council enacted 87 by-laws that included the following pieces of significant legislation;

· General approval of a Peace Time Emergency Plan for the entire Town

· Significant Town involvement in employee assistance programs such as the Ontario Youth Corps Program and CO-ED.

Two sites here OWNC sent shock waves

OWMC stands for Ontario Waste Management Corporation, but to many Milton residents the initials stand for the fear that a huge, toxic liquid waste treatment facility and incinerator will be built in Milton.

'Residents first began to suspect Milton might be high on the list of locations when a map was released in 1983 showing the area (Golden Horseshoe) which was being studied by the OWMC in preliminary testing. A black star called the "centroid" appeared on that simplified map.

The OWMC said then that it meant nothing but this spring hundreds of residents in Niagara Falls, West Lincoln Township, Mississanga, and Milton suddenly found themselves with couriers at the door. These couriers had a package from the OWMC, and inside that package was the stark reality of the final eight OWMC sites.

In fact the final eight sites (three in Milton, two in Niagara Falls, two in West Lincoln, and one in Mississauga) had been reduced from an original 152.

What angered Milton residents so much was that in the map showing the 152 sites, two were shown in Milton. In the map of the final eight, a four-lane highway from the Jim Snow overpass had suddenly appeared heading for Omagh.


Residents, led by Al Lukachko (Milton Environmental Advisory Group) and Chris Austin (Omagh United Taxpayers), quickly moved into action and they were joined by the Tremaine-Britannia Group, long known for its successful fight against the regional garbage dump

The three groups have hired environmental experts and have been joined in the fight by a major effort on behalf on the Town of Milton.

In a three-part thrust Milton is seeking a temporary injunction against the OWMC from selecting a site in Milton. This injunction went to the courts twice during 1984 but was put off each time. The two sides will meet in the Supreme Court of Ontario on March 31.

Milton charges the OWMC has exceeded the mandate as set out when it was created by the Legislature.

PROPERTY ASSESSMENT

and your 1985 Municipal and School Taxes

Regional Offices located throughout Ontario are responsible for assessing all real property for the purposes of municipal and school taxation.

The resulting Assessment Rolls are delivered to municipalities which use them to set their mill rates and compute municipal property tax bills. The amount of property tax you pay on your home or business depends on the

assessed value and the mill rate set by your municipality. The assessed value multiplied by the mill rate will determine your 1985 property taxes.

Open House Sessions Open Houses are your opportunity to fully understand your assessment and to evaluate its equity.

Open Houses are held in every municipality at convenient times and locations, to provide you with the opportunity to discuss your assessment with staff of the Regional Assessment Office.

An assessor will be pleased to explain the basis of your property assessment and is authorized to amend any information as may be necessary prior to the delivery of the Assessment Roll to your municipality. If you have any questions but-are unable to

attend the Open House, please contact your Regional Assessment Office at the address or telephone number shown below. **Assessment Notice**

Property owners and tenants will receive an Assessment Notice only If information regarding their property or assessment was changed during the past year, if the assess-ment was appealed last year, or if the property has been reassessed under section 63 of the Assessment Act. If you receive an Assessment Notice, it may reflect changes you have requested in your school support designation, in the amount of your assessed value, or other recorded information on last year's Notice Appeal Procedure

If, after attending your local Open House, you are still dissatisfied with your assessment, you have a right to appeal it to the Assessment Review Board. The Assessment Review Board conducts informal hearings and is responsible for determining whether the assessment under appeal is fair and equitable with the assessments of similar properties in the vicinity or neighbourhood, and may alter your assessment accordingly.

Appeal Deadline The final date for appealing your assessment is February 12, 1985.

Your appeal must be forwarded, either on a Notice of Appeal Form or as a letter, to the Regional Registrar of the Assessment Review Board on or before February 12, 1985, noting your property address, Roll Number and the reason for the appeal.

To assist you in this regard, Notice of Appeal forms and the address of the Regional Registrar of the Assessment Review Board are available at Open Houses, your Regional Assessment Office, or your municipal office.
