"A meeting was held in the Masonic hall on Friday evening in the interest of Mr. .Wm. Smith, at which Mr. Arthur Johnston of Greenwood, and Mr. J. S. Larke of Oshawa, spoke in the interest of Mr. Smith; and J. C. Smith, the Secretary of the Reform Association, spoke in the interest of Mr. Glen. The chairman, Mr. Henry Bickle, opened the meeting by calling on Mr. Arthur Adhaston, who delivered a very tame address, and frequently referred to the severe handling he had received from Mr. Jury on the Monday night previous.

Mr. Smith, (who is a farmer,) on taking the platform was loudly cheered, and said he appeared in behalf of Mr. Glen. He expressed his surprise at Mr. Johnston pursuing the course he does to-day, and the very opposite in the Local election. Then ho (Mr Johnston) supported a manufacter against Mr. Dryden, and now urged the electors to support Mr. Smith because he is a farmer. The manner in which our constitutional rights were being sacrificed and our Province despoiled by Sir John and his followers was alluded to, and the disallowance of the Streams Bill, the refusal to ratify the Boundary Award, the iniquity of the Gerrymandering Act, and the delusions of the so-called National Policy were dissected in a manner that left their authors in a very unenviable position. In closing his address Mr. Smith held up to the view of the audience Gerrymandered North Ontario, and said that "Sir John might fall down and worship it and commit no idolatry, for there was nothing like it in heaven above, or in the earth beneath, or in the waters under the earth." On taking his seat the speaker was loudly cheered.

Mr. Larke followed and spoke for about one hour and thirty-minutes in defence of the so-called National Policy, but touched lightly on the Gerrymandering Aci. He defended the high tariff of the present Government which protected the stove manufacturers and the other industries, and landed a policy which benefits the rich at the expense of the poor. Mr. Lark was greatly cheered by his Tory friends during the delivery of his address.

Under a 15 and a 17 per cent tariff many of the leading manufacturers in this Dominion had accumulated fortunes ranging from \$150,000 to \$500,000! yet they asked and got more protection from the present Govern-
