The question of increasing the license fees upon pedlars and hawkers in this county and to make it cover soliciting agents who only carry samples as well, came up in committee in the county council on Friday last, and after some consideration was left on the slate for final action when the council reassembles next week. The petition presented in this respect bore the names of over one hundred leading citizens, principally tradesmen, and it is safe to say that about ninety-nine out of every hundred resi dents of the county endorse the sentiments expressed in it. The document de clared that pedlars, hawkers and agents of miscellaneous merchandise are an annoyance to householders, a detriment to the business of established merchants, and of no material benefit to the com-

munity at large. It requires no evidence to substantiate the allegations made, as every one knows they are quite correct. Of late years the entire country has been over-run by dagoes and sheenies, who sell all sorts of goods in rural sections, with peanuts and tropical fruits in cities and towns, contributing very little, if anything, to the revenue of the places where they operate. Their wares are generally shoddy in character and purchasers are thus taken in. These foreign travellers are not always well-behaved, as court records go to show. 
