The County of Essex has the lead administrative responsibility for the physician recruitment office. Mavrincac and her staff receive instructions from the physician recruitment steering committee, which is chaired by Essex County Warden Mike Raymond and Windsor Mayor Eddie Francis and includes the chief executive officers of three area hospitals, councillors from area municipalities and city and county managers.

The initial agreement was for the office to operate for a two-year period with an option to extend for an additional year. The office has reportedly exercised that option which runs through March 2007.

During the meeting Aug.

9 councillors voted to adopt Mavrincac's recommendation to extend the date for review to 2012. Anthony Leardi, the deputy mayor of Amherstburg, and Tom Burton, the deputy mayor of Tecumseh, proposed an amendment to review the agreement in 2009. A five-year renewal schedule, Leardi said, would mean the next county council would have no chance to look at the arrangement. The amendment was defeated.

"I take exception to some members putting a negative spin on this," Burton said. "We're not saying that this isn't working, we're just saying this agreement should be reviewed in 2009... I think it's healthy for every council to review this and I encourage the members to support the amendment."

council and Connie Martin, the executive director of Maryvale Adolescent and Family Services. Martin

spoke specifically about the office's success recruiting psychiatrists to Windsor and Essex County. For years the

PROPOSED PLAN OF CONDOMINIUM

TAKE NOTICE that the Council of the Corporation of the Town of Essex will hold a public meeting on Tuesday, September 12, 2006 at 5:00 p.m. at the Town Hall at 33 Talbot Street South to consider a proposed Plan of Condominium under the provisions of the Planning Act, R.S.O. 1990.

The County of Essex has received Application No. 37-CD-06002 for approval of a Plan of Condominium pertaining to a 26.7 hectare (66 acre) parcel of land located on the south side of the 12th Concession Road and east of Walker Road and know locally as Lucier Estates residential development (see map below for location). The owners of Lucier Estates are proposing a reorganization of its management structure. This reorganization involves changing the status of the current tenure from leasehold to condominium ownership in which the individual sites would be owned by the residents and the common elements (park, community centre, convenience store and postal kiosk) would be collectively owned and maintained by the condominium corporation. In order to effect this change, an application for draft plan of condominium has been submitted to the County of Essex (as the approval authority) and the Town. This proposal does not involve any physical changes to Lucier Estates as no development is proposed. The subject property is designated iHam left in the Co lchester North Official Plan.

ANY PERSON may attend the public meeting and/or make written or verbal representation either in support of or in opposition to the proposed Plan of Condominium.

If a person or public body that files an appeal of a decision of the County of Essex, as the approval authority, in respect of the proposed Plan of Condominium, does not make oral submissions at the public meeting, or does not make written submissions to the County before the proposed draft Plan of Condominium is approved or refused, the Ontario Municipal Board may dismiss the appeal.

If you wish to be notified of the decision of the County of Essex in respect of this proposed Plan of Condominium, you must make a written request, referencing File Number 37-CD-06002, to the County of Essex, c/o Manager of Planning Services, 360 Fairview Avenue, Suite 302, Essex, Ontario N8M 1Y6.
