"I'm probably very anal about the process because basically anything that comes through, I'm reviewing it," she said.

Hunter said Balvert's claim that the Business Improvement Area is not being charged for their use of an office and accounting services is untrue. The BIA's expenses are paid by the BIA levy, she said.

"While this has been the case in the past, in February 2006, based on a report pre-

pared by the treasury department and in a meeting with the BIA, it was resolved that commencing in 2007, the BIA would be charged for accounting and IT services provided by the treasury department, together with a charge for office space," Hunter's report reads. "Additionally, commencing in 2006, it was council's resolution that the BIA reimburse the town for usage of photocopying equipment and the postage meter."

The report also addresses the use of credit cards for

business lunches. Hunter calculated that 10 percent of the credit card purchases reviewed by Balvert were for food.

"The cost of food purchases for lunch meetings on work-related matters account for 0.01375 percent of the total operating expenditures during this 31-month period, excluding transfers to reserves and debt servicing," the report states.

Mr. Balvert was contacted for comment on this story. Messages to his home were not returned.

Hold removed from Kimball development

Essex town council has removed the holding symbol for the Kimball Estates development project.

Chief Administrative Officer Wayne Miller said the holding symbol is removed on a development project when water and sewer services are available at the site.

"As soon as they are ready

to proceed they ask us to remove the hold," Miller said. "They can start building as soon as they have an approved plan of subdivision."

The project includes plans for 16 single-unit detached dwellings and 88 townhouses on the northeast side of Hanlan Street between Fairview and Brien Avenue.

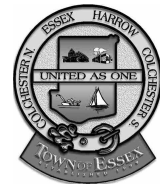
