By using cards rather than cheques for small purchases, we avoid issuing hundreds of cheques each year, resulting in the savings of thousands of dollars in processing costs. This is just one of many efficiencies implemented by our Finance department in recent years."

"When used in the context of "credit card privileges", the word "privileges", by definition, means "a right, advantage, or favour". Purchasing is one of many job requirements of Town managers. The provision of a credit card for the purposes of carrying out a job requirement is not a "right" and provides no personal "advantage" or "favour". Corporate credit cards do allow managers to perform their purchasing function more efficiently and at less cost to the taxpayer."

"We will get a disruption of geese migration and a loss of about \$30 to \$40 million in revenue to this area," Lee said. "The loss of property value based on the European experience is \$1.75 billion."

Ernest Marshall, a resident near Goderich, Ont., told the panel about his experience living 350 metres from five turbines.

He said his ponies went wild and he's suffered seizures because of the turbines.

"These things squeal when they rotate to the extent that it's ear boggling," Marshall said. "I live three miles from the airport and I don't hear the planes there, but I hear the turbines."

Kingsville Mayor Nelson Santos said he was happy with the turnout at the meeting. He said he would be willing to discuss other offers from wind-generated power companies.

"Oh, absolutely," Santos said. "I think many residents are in favour of it and I don't hear them saying they're against clean or green energy. If the right location can be found with minimal impact on the community given our economy and values, we'll consider

If concerns arise regarding this project, which cannot be resolved in discussion with the County of Essex, a person or party may request that the Minister of the Environment make an order for the project to comply with Part II of the Environmental Assessment Act, which addresses individual environment assessments.
