people who live anywhere in the world (except Essex) are entitled to use the pool for \$2.75 per visit. Essex residents, on the other hand, pay \$2.75 per visit, PLUS a mandatory annual dues/ membership/surcharge/levy (whatever you want to call it) added to our property tax bill. For a typical resident

this probably works out to an additional \$100 to \$200 per year. The extra fee must entitle us to certain rights and privileges but I can't seem to find the words to describe them.


Ministry of Transportation, Ontario (MTO) Class Environmental Assessment and Detailed Design **Highway 3 Reconstruction and Widening** (G.W.P. 315-98-00)

THE PROJECT

The Ministry of Transportation of Ontario (MTO) retained Delcan Corporation to complete the detailed design study for the widening and reconstruction of Highway 3 from 0.5 km west of County Road 34 (Talbot Road), easterly 6.9 km east of County Road 8 located in the Town of Essex, Town of Lakeshore and Town of Tecumseh, Essex County, as shown on the accompanying key plan.

The project includes:

- widening Highway 3 from two (2) to four (4) lanes with a grassed median;
- · new concrete pavement with longitudinal tining which produces sound levels comparable to typical asphalt pavements;
- temporary alternative routes for sideroad traffic during construction of concrete pavement at intersections;
- traffic signals and intersection improvements including slotted left-turn lanes at signalized intersections; · illumination upgrades which will include shielded lighting to minimize spill light and light trespass;
- culvert modifications; and, a comprehensive landscape planting plan.



THE PROCESS

The detailed design study followed the planning process for Group "B" projects under the Class Environmental Assessment for Provincial Transportation Facilities (2000), which is approved under the Ontario Environmental Assessment Act.

30-DAY REVIEW OF DESIGN AND CONSTRUCTION REPORT

Copies of the DCR are available for review at the following locations:

A Design and Construction Report (DCR) documenting the environmental assessment, detailed design and the related construction methods/staging will be available on May 2, 2007 for a 30-day public review period. The DCR describes the preferred design and the environmental mitigating measures and provisions that have been incorporated into the construction contract. Although the DCR is not eligible for a Part II Order Request, MTO will consider comments received from the public and agencies. Interested persons are encouraged to review this document and provide comments by June 1, 2007. If there are no outstanding concerns after June 1, 2007, the project will be considered to have met the requirements of the Class EA. No further documentation will be prepared and construction may start without further notice.

Province should intervene in Lakeshore
