During the high wind that prevailed on Saturday night last something in the nature of a cyclone or whirlwind of terrific force struck the farm of John Davidson, of the 11th con., Minto. It arose suddenly with a roar like Niagara and travelled apparently in a path a few rods wide as evidenced by its passage from field to field a few panels of fencing being scattered far and wide while the rest of the fences was undisturbed. In its destructive course stood Mr. Davidson's fine barn erected a few years ago and the cyclone left it a roofless and sorry looking spectacle. The roof, along with the heavy tamarac rafters, was lifted bodily and torn to atoms, the rafters being twisted to splinters and some portions carried 25 rods away. An old log barn on an adjoining farm was also demolished, the heavy logs being tossed about in all directions. Here the cyclone seems to have exhausted its force. The expense of repairing the barn will be considerable and it appears that insurance policies do not cover damage from wind, though they do by lightning. This is a point that should be considered by directors of insurance companies. Such storms are rare in Ontario and probably visit it from across the lines whence come many of our ills, but it is to be hoped that the Kansas cyclone is only a transient guest.—Harriston Tribune.
