Good Hunting in Laurentians



This fine bull moose with 56 1/2-inch spread of antlers was shot in Mount Tremblant Park, Laurentians, about 60 miles east of Mont Laurier, at the end of Canadian Pacific steel, by R. H. Vickers and A. C. Her, Montreal hunters, recently. It came to the call of Gaston Prevost, well-known northern guide who is also fire ranger of the district. When shot, the animal fell into the Cypress River, its 1400-pounds of weight sinking it into the mud. The hunters were forced to improvise a raft of cut logs on which they towed the body to camp. Photographs show close-up of the moose and of the body being towed to camp, the heavily loaded canoe and a snap shot of a passage through shallows. The guide stated that in all his experience he had never seen moose so plentiful in the district.
