LETTERS TO THE EDITOR.

To the Editor of the REVIEW Dear Sir.

Kindly allow me space in your valuable paper to offer a few comments re remarks in last week's Chronicle "Conviction Quashed" Rex vs Mckinnon. As stated in the article referred to, the above conviction was quashed on a mere technical objection in view of the case not having been entered within six months after the offence was committed.

In other respects the judgment has apparently been good as no costs were granted in the case to the Defendant whose expen es will be yery much larger than the Town's expenses will be, he having to pay all Court Costs

A full explanation of the case was given to the ratepayers of the Town on nomination night and the necessity of bringing the suit on, fully gone into, the principal necessity being the defence of the Fire By-Law, which had been attacked as being bad and not capable of enforcement.

The Courts have now decided that our By-Law is good, and although a certain amount of expense has been incurred, it was absolutely necessary to knew if the By-Law could be en-forced. The Editor of the Chronicle concludes the article by stating that this is the fourth judgment given by me that has been quashed by the higher courts, and advises me not to sit on any more cases.

This is one of his many mistatements, as in eight years I have only had two judgments quashed in which I disposed of the case myself.

In this particular case the Town Solicitor submitted his side of the case to outside legal talent who agreed with him in his contentions that a conviction should be made. While on my part, to guard the Town as far as possible against expense, after the evidence was all in and arguments made and noted by the Council on both sides of the case, I reserved judgment for a week and submitted the whole case, including eyidence, arguments of Counsel, &c., to Mr. Kingston K. C. of Mt. Forest. After a careful reference to the Statutes, &c., he believed that a conviction should be made and largely framed the judgment which was

If Mr. Irwin will watch the legal columns of the Toronto papers for a few days he will find that it is a daily occurrence for judgments of even the High Courts to be reversed, although these are supposed to be making a daily study of the Statutes and law of the land.


