County Council. Continued from last week. Thursday Afternoon. At this session all the members were present, but only a short time, as the Bruce County Council and Warkton visitors were expected and no heavy business was taken up.

Friday Afternoon. Council met on Friday afternoon at 2 p.m. The following reports were presented and adopted: Report of Roads and Bridges; County Property; Printing; House of Refuge, and a special report from Mr. Shute on bridges in his division.

Friday Evening. At this session an account from Jas. S. Russell for \$55; also reports of Finance and educational. Both of the latter were adopted.

Mr. Shute presented report of Roads and Bridges recommending payment of accounts from A. C. Patterson \$2.70; J. J. Richardson \$35.00; that with reference to request of Bruce for an expenditure on county boundaries, while the committee was in sympathy with the move it could not recommend anything further than the usual keeping in repair of the county bridges.

Some discussion took place on the by-law relating to school inspectors salaries, on account of some changes in the legislation of late. Mr. N. W. Campbell inspector of South Grey, who was present, claimed that there was a mistake in the copy of by-law regarding his salary. The by-law was passed.

Messrs McKinnon and McLean followed this action closely with a motion that the council do not in future guarantee the debentures of any municipality in the county. Speaking to the motion Mr. McKinnon said he did not feel sorry over the refusal to guarantee Durham's debentures, but this action being taken would prevent applications being made by the municipalities for such a guarantee.
