DURHAM WON AT HOME.—The first league hockey game for Durham on New Year's night attracted a large number of the citizens many of whom probably had never previously witnessed a real hockey match. Unsuitable rink accommodation prevented Durham placing a team on the ice in previous years, but with the large area of open ice space in the new rink. It provides hockey facilities unequalled in this district. Hanover were the opponents and on them, fresh from their walkover with Millmay a week previously, the tables were completely turned. The Durhams were always in the lead and wound up 6 goals ahead, 11 to 5. Although previously without a team, the majority on the town line-up have in past years figured in hockey circles, as the score demonstrated, but until almost a month ago, had never played together. They are a fast bunch, and should prove winners, or at least the runners-up, in the district. Owing to the sporting editor being otherwise engaged that evening, we are unable to give a detailed report. Before next week's issue, the Durhams play two away-from-home games, at Midway Friday and in Hanover next Wednesday night. Following was the home line-up last Friday: Goal—Murphy, point—Wilson, cover point—Cowan, rover—Cameron, left wing—Livingston, right wing—Begley, centre—Lavelle.

## Municipal Elections.

Wm. Laidlaw, Mayor of Durham S. P. Saunders, Reeve. Durham. After keen contests the above gentlemen defeated respectively Wm. Black and Wm. Calder for the two principal town offices. Mr. Laidlaw has the unique honor of capturing the Mayorality a second time after years of absence from the Council, and Mr. Saunders has the honor of defeating in turn two of the strongest municipal men the town has produced.

The vote for the council also showed surprises but the six "good men and true" elected have all, with one exception, had municipal experience, and as the exception, Mr. T. C. Morton, heads the list there is no fear but that they will give a good account of them selves.

In the trustee election in the North Ward Mr. J. P. Hunter was the winner by a good majority. It is of no consequence now to discuss influences that may have contributed to the above results: the losers are all good losers, the winners have the interest of the town at heart: in every election good men must fill.

The by-laws, as will be seen were both carried by good majorities. It is surprising though how many there are who voted nay. They are presuming, no doubt, that they will be carried anyway, and vote as they do, as an admonition. It would be interesting could they be lined up, to ask them to formulate an alternative plan which they would favor.

Bentick. The contest for the reeveship proved a walk-over for Mr. J. S. Wilson, the present reeve who had over 100 of a majority against Mark Willis. Dodsworth is Dep-Reeve and the councilors are Grierson, Alex. Wilson and Wm Lunner, the latter a new man replacing Noble.

Normanby. Reeve Schenk as we announced was elected by acclamation. Dep-Reeve Umbach was re-elected by a majority of 77 over Hahn in spite of influential opposition. We regret to notice that Mr. R. Barber of the council candidates was the one to fall, the councillors being Baets, Kenna and Shiel.

Artemesia. Mr. A. Muir, an old and tried friend of the township has met his first defeat, taking 304 votes to Mr. Boyd's 430. McKenzie is Dep-Reeve by acclamation. The Councillors are Wright 306, Duncan 361, Carson 350. The losers were Best with 345, McLoughry 174.

Hanover. A very graceful thing was done here by electing by acclamation Mr. D. Knechtel as Mayor, and Dr. Mearns as Reeve. Markdale elected Wm McFarland as Reeve over Dr. Campbell. Owen Sound not only carried Local Option, it elected every candidate who supported Local Option. Harrison is Mayor.

Obituary. W. H. SHAW. On Monday last the sad fact became known that Mr. W. H. Shaw had breathed his last. He had not been well for some months back, but not until lately was the fatal termination expected. He is survived by his wife and three children: Charles in New York, John in Sarnia, and Mrs. Irwin, Hamilton, who will all deeply mourn.

Deceased was a tanner by trade, though latterly, before his illness, he found employment in the Furniture Factory. He was a member of the Methodist church, a respected citizen, and had reached his 68th year. He is to be buried on Thursday. Service at 1:30 p. m.

## How Local Option Fared.

The results of the many contests on Monday to put in force or to repeal Local Option, proved that the sentiment against the bar room and treating system is not on the wane throughout the country. Only in one instance out of many tried was a repeal successful, in Hepworth, and that by a majority of 11 only.

It has been abundantly proved that a majority vote is quite sufficient to retain it on repeal, hence the agitation for the removal of the objectionable three-fifths clause will gain strength. In quite a number of places the 3-5ths requirement was not reached, though there was a good majority, and by this means some 60 bar rooms have been saved.

In Egremont, a repeal vote was brought on, and it will likely be the last, for the majority of three years ago, was largely increased. The eyes of all Ontario were turned to Owen Sound, where gigantic efforts were made to discredit local option by its overthrow. An appeal was made to the "trade" throughout Ontario for funds to fight the temperance faction, and funds no doubt were forthcoming, but the effort has failed, the measure being sustained by a majority of 103, less than 3 years ago, but a fine result considering the efforts made to prevent it.

The tendency of the times is surely against liquor and the treating system. Another tendency, and one most desirable, is to separate hotel-keeping and hotel-keeping. Hotel-keeping is an honorable occupation: the business of the open bar is degrading and destructive to the best interests of the community.
