Company Formed to Exhibit His Many Discoveries.

Will Push His "Discoveries" to the Public.

Others Doubtful.

The Big Show Paid by Parsons of Charitable Event.

San Francisco, March 1.—The Elf light that his discoveries may be generally distributed and, incidentally, that his work may not be hampered by the business worries, the brains and genius of Luther Burbank, the plant wizard, have been capitalized for several million dollars.

The new company, Cook & Hogan, right to distribute to the world the plant discoveries of the Santa Rosa naturalist are Hartland Law and his brother, Robert, his son, George, two millionaires of this city, and Oscar E. Danner, a wealthy eastern capitalist.

There is no limit to the rights which the men have secured, except one or two small contracts, which Burbank is fulfilling. Working alone, Burbank has not had time to give the results of all of his experiments to the public, but now a systematic effort will be made to distribute both his past and future products to the world.

One of the first things to be undertaken by the new company will be the full development of the spinellose cactus, which promises to transform the desert lands into grazing lands for cattle. In this connection it is announced that Burbank has developed a cactus capable of producing saccharin, a material which will yield both sugar and alcohol.

Burbank, when asked regarding the formation of the new company, said:

"It is a fact that Mr. Herbert Law and his brother, and Mr. Oscar E. Danner, handling my products, with the exception of a few varieties, which are ready to be sold, I am glad to be rid of the business end. It will give me so much more time for the development of more fruits and flowers."

The company will be called "The Luther Burbank Products, Incorporated."

INSTANT DEATH.

Restaurant Keeper Electrocuted in Front of His Business Place.

Eric, Pa., March 1.—John Kneehel, a prominent restaurant keeper on the East Side, was killed by a live wire in front of his place of business, 101 Parade street, yesterday afternoon. Linemen of the Bell Telephone Company were engaged making repairs to power lines arranged by the recent storm. Mr. Kneehel stepped out while the linemen were at work, when a dancing wire, which had become crossed with the electric light high voltage cable, struck him in the face. He fell to the pavement without a murmur. Friends rushed to his assistance and an ambulance was hurriedly summoned, but examination proved that he was dead. Mr. Kneehel is survived by his widow and three daughters.
