Earthquakes. The most notable and disastrous earthquakes on record are those of Italy (526), when 129,000 persons perished, and of Sicily (1033) when 60,000 lost their lives. According to Gibbon, toward 642 each yr. was marked with the repetition of earthquakes of such duration that Constantinople was shaken above forty days—of such extent that the shock was communicated to the whole surface of the empire.

A Brutal Husband. One of the most fiendish acts, that it has been our duty to chronicle for a long time, took place on the night of Thursday the 25th ult. One Wettland, a farmer residing about two miles from Midway, quarrelled with his wife, about some trifling matter, and after abusing and beating her in a shameful manner, turned her out of doors. He supposed she had fled for safety to a near neighbor, sent his daughter—a mere child—for her. After waiting a considerable time for their return, in a fit of frenzy, he resolved to fire the house, for that purpose he gathered a pile of straw and inflammable substances, which he carried up stairs and piled around the stove pipe, drenching the whole with coal-oil, applied a match and left the house, leaving his little boy of about two years and an infant a few months old to perish in the flames. Where he passed the remaining hours of the night is not known, but before going to the station to take the six o'clock train, south he visited the stable and with a sharp axe cut and lashed the back of two cows in a frightful manner. Next day the neighbors becoming suspicious and alarmed, broke into the house, and found matters as above related, and the little boy standing by the cradle with his hands and feet dreadfully frozen. A warrant for his arrest was immediately issued by the Justice of the Peace, but has been unsuccessful in tracing him.—Teenwater News.

FATAL RESULT OF A BRUTAL ASSAULT.—Mrs. Haugh, the old woman who was so brutally assaulted by the notorious Tom Kenny on the 11th of January, and who since then has been lying in the St. Joseph's Hospital, died last Tuesday night. It will be remembered that on the night in question, Kenny entered the House of Mrs. Haugh, and severely without the least provocation beat her in a most unfeeling manner, from the effect of which she never recovered. On Friday Mrs. Haugh was taken suddenly ill, and the matter coming to the ears of Chief Randall, he and the Police Magistrate visited the patient with the intention of obtaining her deposition. She was so low, however, that nothing in this direction could be done at that time, nor since. Kenny is a disreputable character, and well known in police circles. A few years ago he received a term of two years in the Penitentiary for stabbing his father in the eye with a knife and since his release has been before the Police Magistrate a number of times for various offences.
